INTRODUCTION

This document is a Consent Agreement regarding Cynthia G. Davis' license to practice registered professional nursing in the State of Maine. The parties enter into this Agreement pursuant to 10 M.R.S.A. § 8003(5)(B), (5)(D) and 32 M.R.S.A. § 2105-A(1-A)(C). The parties to this Consent Agreement are Cynthia G. Davis, Maine State Board of Nursing ("Board") and the Office of the Attorney General, State of Maine. An informal conference was on February 12, 2003. The parties reached this Agreement based on Ms. Davis' failure to comply with her obligations under the terms and conditions of a Consent Agreement dated May 3, 1999.

FACTS

1. Cynthia G. Davis was originally licensed to practice in Maine as a registered professional nurse in 1988.
2. On May 3, 1999, Cynthia G. Davis, R.N. entered into a Consent Agreement for the reinstatement of her registered professional nursing license for a probationary period. See Consent Agreement, Exhibit A.
3. The terms of the Consent Agreement in Paragraphs 3, 4, 5 and 6, require Ms Davis to provide the Board with information to monitor her substance abuse treatment and her nursing practice. Ms. Davis admits that she has failed to comply with the terms of the May 3, 1999 Consent Agreement.
4. Cynthia G. Davis has offered to surrender her registered professional registered nursing license.

AGREEMENT

5. The Maine State Board of Nursing will accept Cynthia G. Davis' voluntary surrender of her license, license #R031400, and Ms. Davis agrees and understands that the voluntary surrender of her license will be for an indefinite period.

6. Cynthia G. Davis agrees and understands that her license will not be reinstated until and unless the Board, at Ms. Davis' written request, votes to reinstate Ms. Davis' license. When considering whether to reinstate Ms. Davis' license, the Board will consider whether Ms. Davis is medically capable to provide safe nursing care. She also understands and agrees that if the Board reinstates her license it will be for a period of probation with terms and conditions that the Board in its discretion deems appropriate.
7. Cynthia G. Davis understands that this document is a Consent Agreement that affects her rights to practice registered professional nursing in Maine. Ms. Davis understands that she does not have to execute this Consent Agreement and that she has the right to consult with an attorney before entering the Consent Agreement.
8. Cynthia G. Davis understands and agrees that if she petitions the Board for reinstatement, as a condition of reinstatement of her registered professional nursing license she will arrange for and ensure the submission to the Board of a report regarding treatment and therapy for substance abuse and any continuing treatment she is receiving, and that she is able to return to work. In addition, Ms. Davis agrees and understands that the Board shall have access to any and all medical records and all otherwise confidential or medically privileged information pertaining to her treatment and therapy which the Board deems necessary to evaluate Ms. Davis' ability to return to work. Ms. Davis shall notify her health care physician of her substance abuse problem.

Cynthia G. Davis shall provide such information, shall authorize any release of such records and information, and shall authorize any such discussions and communications with any and all persons involved in her care as may be requested by the Board for the purpose of evaluating Ms. Davis' compliance with this Consent Agreement.
9. Cynthia G. Davis shall not work or volunteer, in any capacity, for a health care provider as defined by Title 24 M.R.S.A. § 2502 (2) or in any position holding herself out as a registered professional nurse or with the designation, R.N. while her nursing license is surrendered.
10. Modification of this Consent Agreement must be in writing and signed by all parties.
11. Cynthia G. Davis affirms that she executes this Consent Agreement of her own free will.


