CONSENT AGREEMENT  
 FOR VOLUNTARY  
 SURRENDER OF LICENSE

INTRODUCTION

This document is a Consent Agreement ("Agreement") regarding Megan Rohan's license as a registered professional nurse ("RN") in the State of Maine. The parties to this Agreement are Megan E. Rohan ("Licensee" or "Ms. Rohan"), Maine State Board of Nursing ("Board") and the Office of the Attorney General, State of Maine. The parties enter into this Agreement pursuant to 32 M.R.S. §2105-A (1-A) (C), 10 M.R.S. §§ 8003 (5) (A-1) (4), 8003 (5) (B) and 8003 (5) (D). The parties reached this Agreement on the basis of: 1) a Board Complaint dated April 30, 2012, which includes a Provider Report from Portsmouth Regional Hospital ("Portsmouth") dated April 27, 2012; 2) correspondence from the Licensee's attorney dated June 26, 2012; and 3) correspondence from the Maine Medical Professionals Health Program dated August 13, 2012.

FACTS

1. Megan E. Rohan has been licensed as an RN to practice in Maine since September 25, 2008. Most recently, she has been working under her Maine compact license multi-state privilege in New Hampshire.
2. Megan E. Rohan was employed as an RN at Portsmouth from May 2, 2011 until her termination on April 18, 2012 due to diversion of controlled substances. During a routine review of controlled substance access reports, Ms. Rohan appeared on the report for accessing controlled substances at a statistically higher removal rate than her peers. Following Portsmouth's internal investigation, it was discovered that Ms. Rohan removed a substantial amount of narcotics which were not documented as being administered to patients [attached hereto, incorporated herein, and marked as Exhibit A]. When confronted by personnel conducting the investigation at Portsmouth, Ms. Rohan admitted that she diverted the medications and "took them home."
3. Megan E. Rohan contacted the Medical Professionals Health Program ("MPHP") on April 18, 2012 to discuss participation in its monitoring program; she met with Clinical Director Margaret Palmer on May 1, 2012. At that initial meeting, Ms. Rohan disclosed to Ms. Palmer that she had been terminated from her position at Portsmouth due to a drug-related incident; she presented herself as a licensed nurse with a drug dependency that had existed for some time. Ms. Rohan advised Ms. Palmer that she was currently working at a clinic, Families First, where "she had no access to drugs and, therefore, was not a threat."

According to MPHP's correspondence to the Board, although Ms. Rohan signed an Evaluation and Treatment Agreement, which obligated her to begin the process of appropriate treatment by having a comprehensive psychological evaluation, she failed to follow through despite multiple attempts by Ms. Palmer to do so. On June 1, 2012, Ms. Palmer received word from Attorney Ronald Schneider that Ms. Rohan would be surrendering her nursing license.

4. Megan E. Rohan has offered to surrender her registered professional nursing license based upon the above-stated facts and thereby waives her rights to an adjudicatory hearing.

### AGREEMENT


5. The Maine State Board of Nursing will accept Megan E. Rohan's offer to voluntarily surrender her registered professional nursing license. Ms. Rohan neither admits nor denies the above-stated facts; however, she understands and agrees that should this matter go to hearing before the Board on the above-stated facts and the underlying information to support those facts, it is more likely than not they would support the Board's findings in this Agreement. Further, she understands and agrees that this document imposes discipline regarding her nursing practice in the State of Maine. The grounds for discipline are found under Title 32 M.R.S. § 2105-A(2) (A), (2) (B), (2) (F) and (2) (H) and Chapter 4, Sections 1(A) (1), 1(A) (2), 1(A) (6), 1(A) (8) and Chapter 4, Sections 3(F), 3(K), 3(P) and 3(Q) of the Rules and Regulations of the Maine State Board of Nursing. Specifically, the violations are:
  - a. Title 32 M.R.S. §2105-A (2) (A). Ms. Rohan engaged in the practice of fraud or deceit in connection with a service rendered within the scope of her license. See also: Board Rule Chapter 4, Section 1.A.1.
  - b. Title 32 M.R.S. §2105-A (2) (B). Habitual substance abuse that has resulted or is foreseeably likely to result in the licensee performing services in a manner that endangers the health or safety of patients. See also: Board Rule Chapter 4, Section 1.A.2.
  - c. Title 32 M.R.S. §2105-A (2) (F). Unprofessional Conduct. Ms. Rohan has engaged in unprofessional conduct by violating standards of professional behavior that have been established in the practice for which she is licensed. See also: Board Rule Chapter 4, Section 1.A.6.
  - d. Title 32 M.R.S. §2105-A (2) (H). A violation of this chapter or a rule adopted by the Board. See also: Board Rule Chapter 4, Section 1.A.8.
  - e. Board Rule Chapter 4, Section 3. *Unprofessional Conduct* as defined by the Rules and Regulations of the Maine State Board of Nursing states that, *Nursing behavior which fails to conform to legal standards of the nursing profession, and which could reflect adversely on the health and welfare of the public shall constitute unprofessional conduct and shall include, but shall not be limited to, the following:*
    - F. Failure to take appropriate action or follow policies and procedures in the practice situation designed to safeguard the patient.
    - K. Inaccurate recording, falsifying or altering a patient or health care provider record.
    - P. Diverting drugs, supplies or property of patients of health care provider.
    - Q. Possessing, obtaining, furnishing or administering prescription drugs to any person, including self, except as directed by a person authorized by law to prescribe drugs.
6. Megan E. Rohan understands and agrees that her nursing license will remain on surrender status and subject to the terms of this Agreement indefinitely until and unless the Board, at her written request, votes to reinstate her license. Ms. Rohan understands and agrees that if the Board reinstates her license, it may be for a probationary period.
7. The State of Maine is a "Party state" that has adopted the Nurse Licensure Compact ("Compact"), which is set out in Chapter 11 of the Board Rules. The State of Maine is Ms. Rohan's "Home state" of licensure and primary state of residence, which means that she has declared the State of Maine as her fixed permanent and principle home for legal purposes; her domicile. Other Party states in the Compact are referred to as

"Remote states," which means Party states other than the Home state that have adopted the Compact. Ms. Rohan understands this Agreement is subject to the Compact.


8. Megan E. Rohan understands that she does not have to execute this Agreement and has the right to consult with an attorney before entering into the Agreement.
9. Megan E. Rohan shall not work or volunteer in any capacity for a health care provider as defined by Title 24 M.R.S. § 2502 (2) or in any position holding herself out as a registered professional nurse or with the designation "RN" while her nursing license is surrendered.
10. This Agreement is a public record within the meaning of 1 M.R.S. § 402 and will be available for inspection and copying by the public pursuant to 1 M.R.S. § 408.
11. This Agreement is subject to the federal reporting requirements pursuant to Section 1128E of the Social Security Act and 45 CFR Part 61 and any other interstate/national reporting requirements.
12. Modification of this Agreement must be in writing and signed by all parties.
13. This Agreement is not subject to review or appeal by the Licensee, but may be enforced by an action in the Superior Court.
14. Megan E. Rohan affirms that she executes this Agreement of her own free will.
15. This Agreement becomes effective upon the date of the last necessary signature below.

I, MEGAN E. ROHAN, RN, HAVE READ AND UNDERSTAND THE FOREGOING CONSENT AGREEMENT. I UNDERSTAND THE EFFECT IT WILL HAVE ON MY NURSING LICENSE. I UNDERSTAND THAT BY SIGNING IT, I WAIVE CERTAIN RIGHTS. I SIGN IT VOLUNTARILY, KNOWINGLY, AND INTELLIGENTLY AND AGREE TO BE BOUND BY THIS AGREEMENT. I UNDERSTAND THAT THIS CONSENT AGREEMENT CONTAINS THE ENTIRE AGREEMENT AND THERE IS NO OTHER AGREEMENT OF ANY KIND.



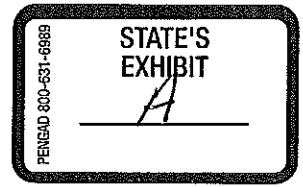
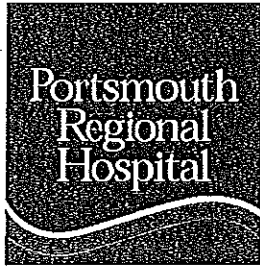

To Whom it May Concern at the Maine State Board of Nursing,

RE: Megan Elizabeth Rohan, 9 Lemont Lane, York, ME 03904 License #RN55671 acting in a compact license status in the State of NH.

During routine review of controlled substance access reports, Megan appeared on the report for accessing controlled substances at a statistically higher removal rate than her peers. We conducted an investigation of her removal and administration of controlled substances and discovered that a very high number of narcotics were removed and never documented as administered to a patient. Please see the attached report. We investigated all dates in which Megan worked at Portsmouth Regional Hospital in 2012. Upon interview, Megan admitted that she diverted the medications. She "took them home". Due to the timing of her last date working at Portsmouth Regional hospital on March 25<sup>th</sup> and the dates of the investigation in April, Megan was not asked to submit to urine drug screening. Megan was terminated from Portsmouth Regional Hospital on 4/18/12 for violation of the NH Nurse practice act RSA 326-B:37 II (n) Diversion or attempts to divert drugs or controlled substances. This has also been reported to the NH DEA and Board of Pharmacy due to the magnitude of the number of missing narcotics. Megan was encouraged to get help and self report the Board of Nursing.
