## 1.0 Population & Demographics

**1.1 Average Daily Population (ADP)** The ADP has changed significantly over the last six years. From its peak in 2018 the census for both male and female residents have seen a continuing decrease except for females ticking back up in 2022. From the high in 2018 to the current year 2022, there was a decrease of 712 male residents (32%). In comparison, the female population decreased by 97 since 2018 (41%).

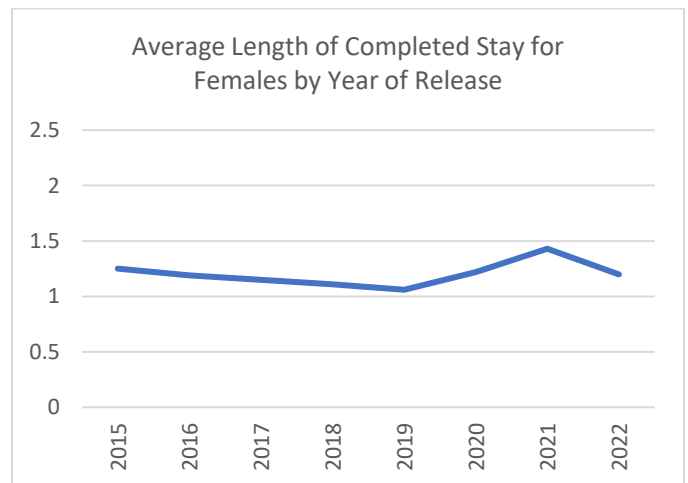
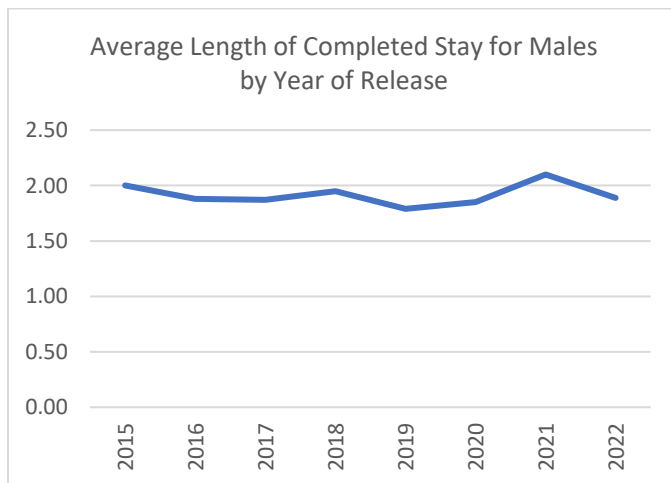

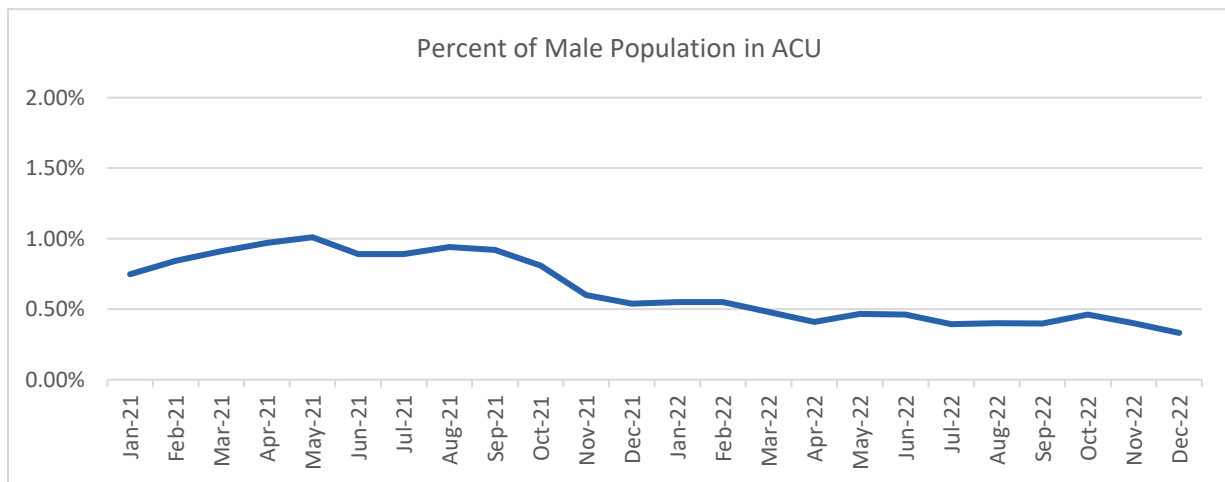
## 1.4 Administrative Control Unit Population

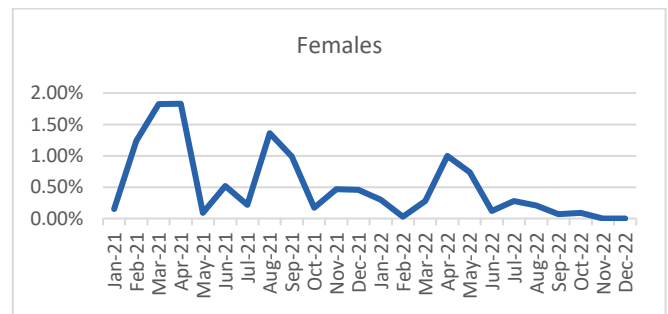
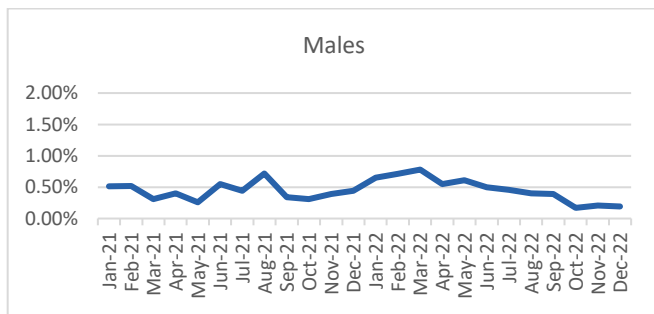

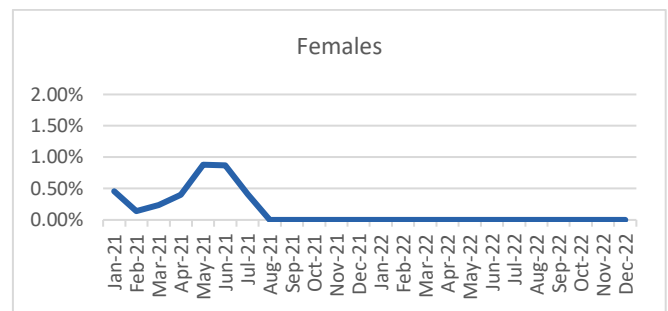
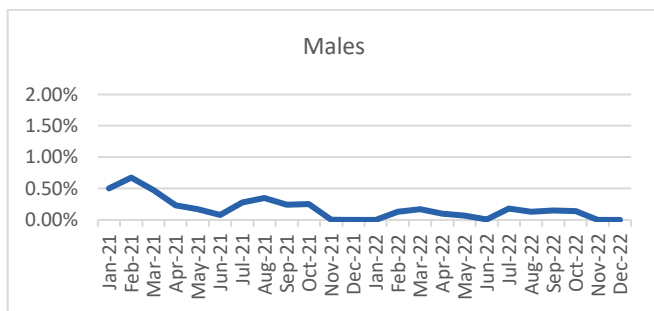
## Average Daily Population in Restrictive Housing as a Percent of MDOC Total Population

## 1.6 Intensive Mental Health Unit Average Population

The Intensive Mental Health Unit (IMHU) is located at the Maine State Prison. The purpose of the IMHU is to treat and help stabilize those with severe and persistent mental health conditions within MDOC adult facilities, as well as residents of county correctional facilities who need intensive mental health stabilization services. The average daily population (ADP) year over year has not varied much, although the day to day census varies within a few residents.

## 2.0 Correctional Programming

### 2.1 Case Management

#### 2022 Facility Case Management

2022 was a year that saw much growth in the case management team for the MDOC Adult Facilities. We collectively looked at a national pandemic in the rear-view mirror, and traditional case management functions returned to practice while many tasks required during the previous years were discontinued.

Case management gatherings at Central Office returned with a targeted training. Case Managers received a two-day training on Motivational Interviewing. With the opening of the new Maine Correctional Center, all case managers were invited to spend a day there and enjoy a tour. LSI-r trainings were also provided as needed.

2023 welcomes several promising opportunities for the Case Management Team to continue to enhance their skill set and their overall case management practice. Bi-monthly gatherings will continue while monthly Brown Bag virtual trainings are being made available to all case managers looking to further their skills. A massive effort to bring risk reduction programming back online for 2023 will allow the Case Management Team to align their facilitation to the Department’s mission.

## 2.2 Medications for Substance Use Disorder (MSUD) Initiative

Providing medications for individuals diagnosed with an OUD is considered a gold standard of care that helps individuals maintain and sustain long-term recovery. MDOC’s MSUD services utilize buprenorphine and naltrexone as primary medications.

Below is the timeline of MDOC’s MSUD initiative, from implementation through full universal access to MSUD treatment services:

- July 1<sup>st</sup>, 2019: pilot MSUD treatment began
- January 2021: Normalized medication administration process initiated. Expansion plans announced to staff, residents and broader community.
- February 2021: Eligibility criteria expands to include those 12 months from transition to the community. Normalized medication administration continued (implementation conducted in phases between facilities).
- May 2021: Eligibility criteria expands to include those 24 months from transition to the community as well as anyone receiving active treatment of Hepatitis C infection regardless of community transition date.
- July 2021: All adult correctional facilities offer fully normalized MSUD medication administration.
- August 2021: Universal access (open enrollment) available in all adult correctional facilities for clinically indicated residents regardless of timeframe to community transition.
- 2022 full universal access continues at all facilities

Prior to discharge from MDOC custody residents receiving MSUD services are provided with comprehensive discharge planning including linkages to community-based continuity of care services. Groups Recover Together and Day One assist MDOC with securing post-release community MSUD appointments and the Portland Recovery Community Center (PRCC) assists with making connections to the broader statewide recovery community and recovery coaches. At discharge, residents receive a copy of their release plan, an MSUD bridge prescription, and a naloxone (Narcan) kit with an education resource for overdose response for the resident and their family and friends.

As of December 31, 2022, approximately 46% of MDOC residents are receiving MSUD treatment services. The following table demonstrates the growth of MSUD treatment services from the pilot year through the end of 2022.

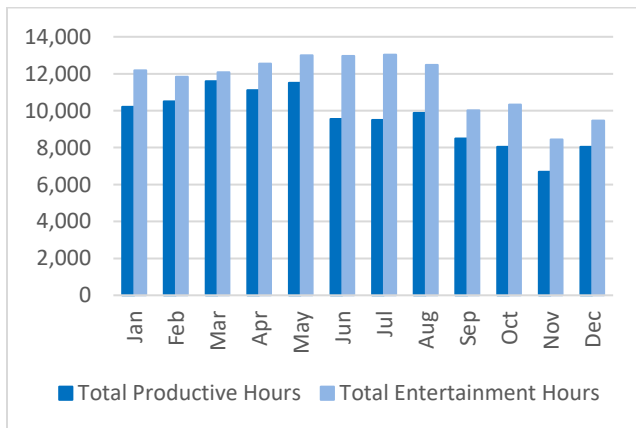

There are over 800 programming and entertainment tablets available to residents at specific levels in the following facilities: Maine State Prison, Maine Correctional Center, and Mountain View Correctional Facility. They are corrections grade and operate on a closed, managed network that allows residents access to thousands of hours of free academic, vocational, life skills, and therapeutic programming designed for all learning levels.

## 3.6 SCCP Cases

The purpose of the Supervised Community Confinement Program (SCCP) is to provide a means of successful reentry of adult facility residents into the community. Residents transferred to supervised community confinement are still considered to be in the legal custody of the Department while in the program. The place of confinement is in the community, rather than in a Department facility. Participation in this program is a privilege which may be afforded to eligible residents who meet the criteria.

“SCCP Placements” are new placements into the community on SCCP status and “SCCP Violations” are those returning to a secure DOC facility from the community who have violated the conditions of the SCCP program.

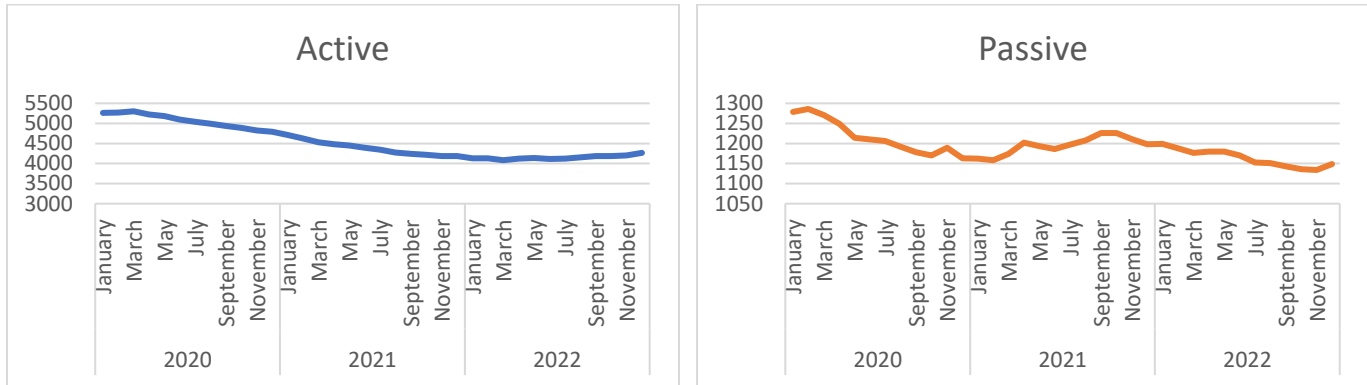

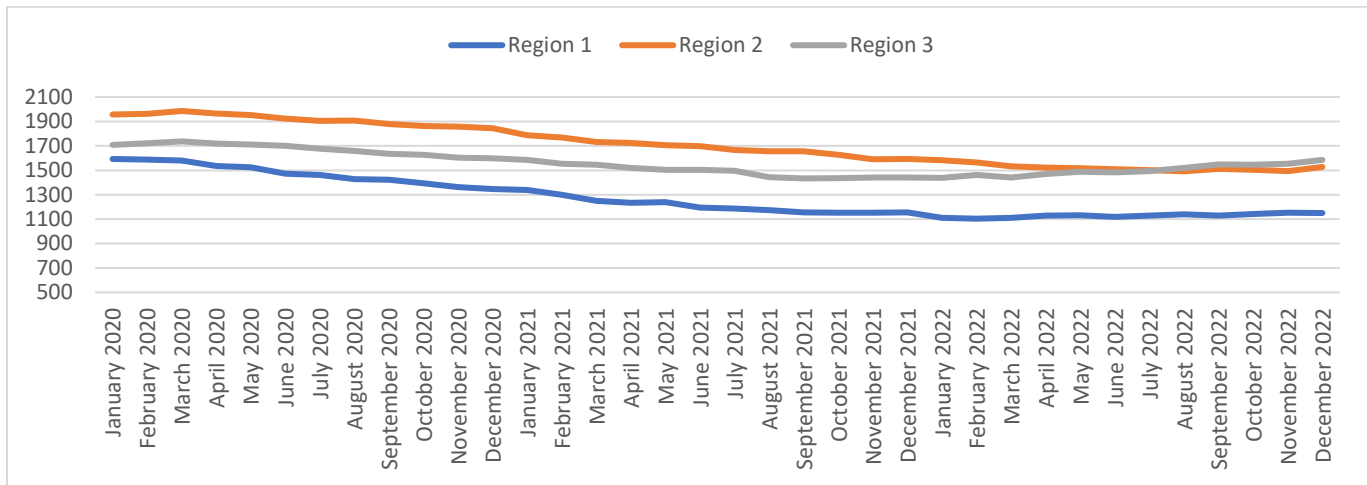

### Adult Community Corrections Population Overtime

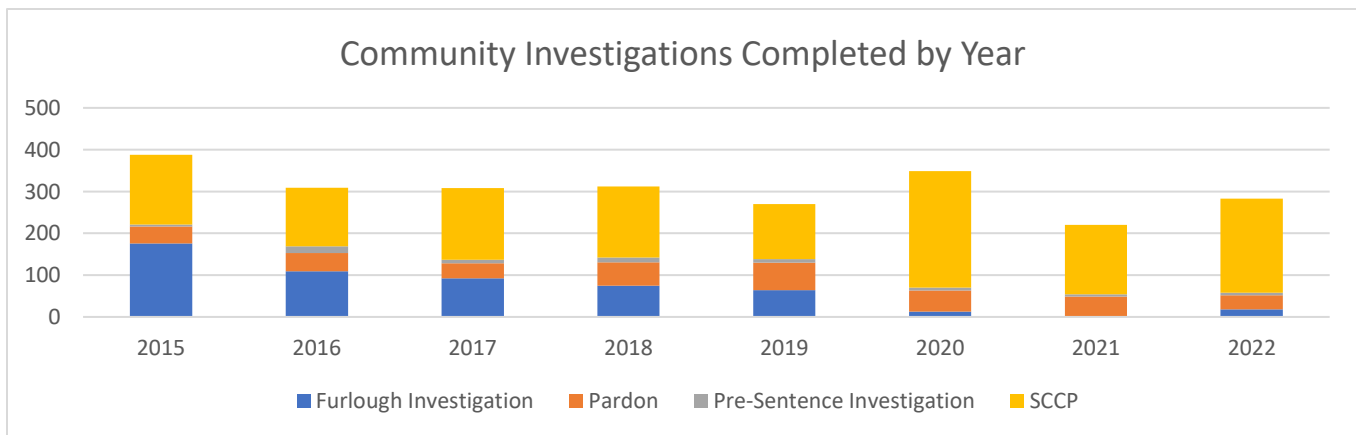

### Community Investigations Completed by Year

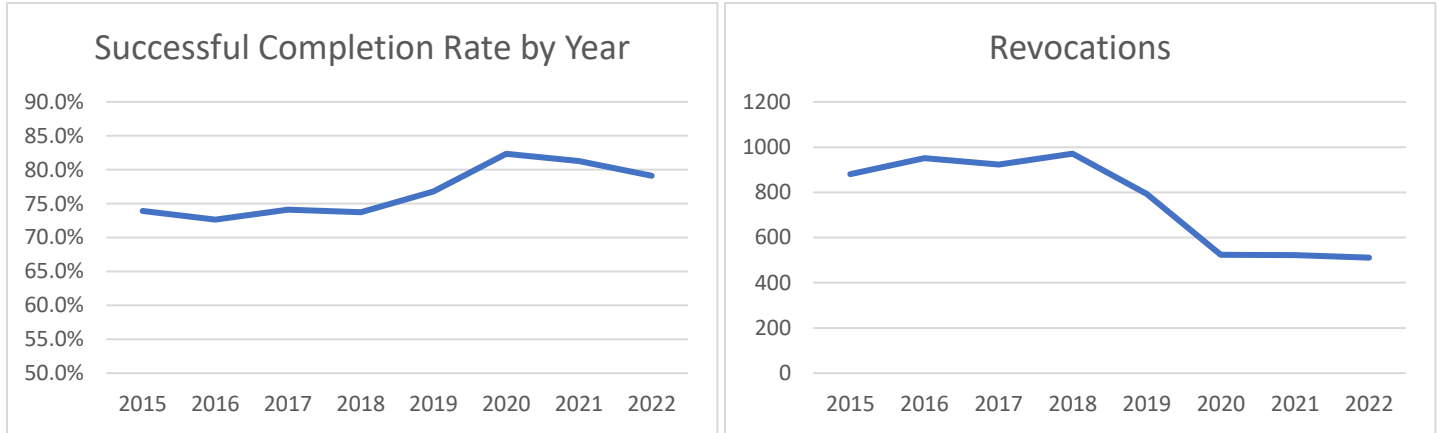

## Probation Revocation and Successful Completions:

A completion of probation is considered successful when a client is transferred from probation to society because their probation has terminated due to completion of the sentence. Should a client have a full revocation, or a partial revocation with termination, then their probation ends unsuccessfully.

## Community Transition House - Leading the Way

In August 2021, MDOC opened “Leading the Way” Transitional Living Program in Bangor. The community-based transitional residential program provides a safe, structured, living residence designed around engagement with needed supports and services, including behavioral health, independent living skills, and other targeted intervention services to help individuals rebuild after justice involvement. At the end of 2022, 12 men live at the residence. All are able to stay rent free for up to 6 months. Applications to live in this dormitory style home come from MDOC facilities Supervised Community Confinement Program (SCCP), which allows qualified residents to finish their sentence while living in the community. MDOC’s probation clients and community-based individuals deferred through criminal justice programs like drug court may also apply.



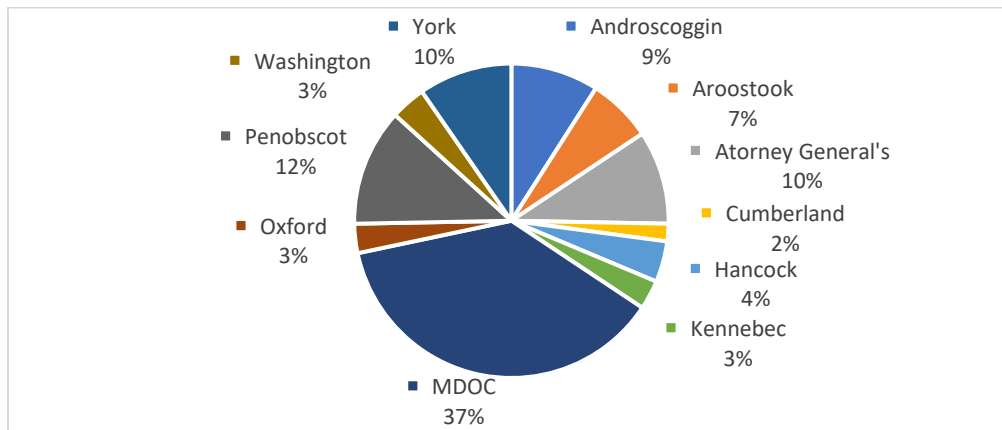

## 5.0 Office of Victim Services

The MDOC OVS is required to ensure that victims who request notice of release receive it according to Maine Criminal Statutes 17-A §2106 “Notification of defendant’s release or escape”. MDOC polices were formed outlining preferred practice. The Statute requires victims to submit a Victim Notification Request with the office of the attorney for the State or directly to the MDOC in order to receive notification of release. Once a Victim Notification Request is filed, the victim must receive notice of the resident’s unconditional release and discharge from institutional confinement upon the expiration of the sentence or upon release from commitment under Title 15, section 101-D or upon discharge under Title 15, section 104-A and must receive notification of any conditional release of the resident from institutional confinement, including probation, supervised release for people with problem sexual behavior, parole, furlough, work release, funeral or deathbed visit, supervised community confinement, home release monitoring or similar program, administrative release or release under Title 15, section 104-A; and must receive notification of the resident’s escape.

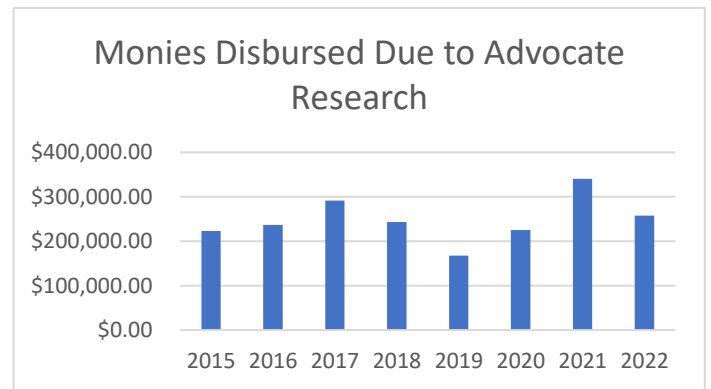
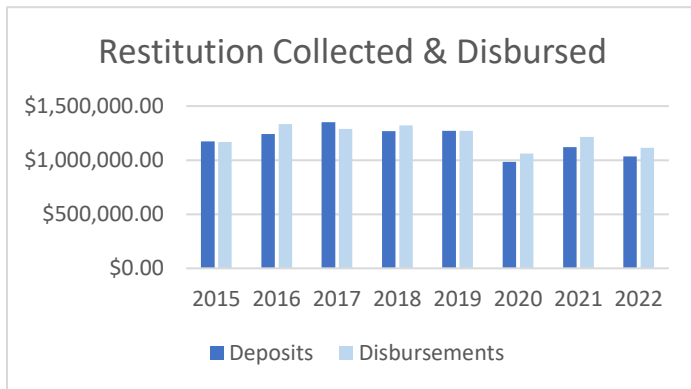

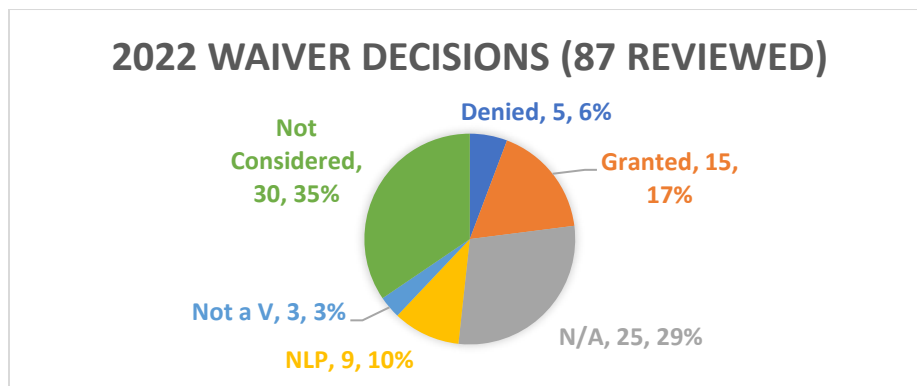

The OVS assisted victims with restitution in which they are to receive per Court order for losses they have incurred. OVS provided information and resources related to these restitution cases in which the MDOC is responsible for the collection of such restitution either through Probation, at the facilities or through the Maine Revenue Service. The OVS acts as a liaison between the victim and Probation and Parole, District Attorney’s Office and the Courts in order to provide resources, information and options for the victim to obtain their restitution while advocating for victims and advising victims of their rights.

According to policy 6.3, contact with victims, waiver requests for contact are reviewed and approved by the Commissioner, or designee. The OVS continues to assist MDOC facility staff providing support regarding this policy. The Director of Victim Services reviews all waiver requests as the Commissioner’s designee.



OVS participates in several statewide stakeholder commissions, panels, and other board and association memberships in order to be a voice for victims and an information source regarding the rights of victims. Additionally, presentations are made regularly in order to promote victim services and educate the MDOC and other stakeholders across regarding victims’ rights and statutes, the victim services offered at the MDOC, and policies and procedures pertaining to such. The OVS completed 19 presentations and trainings in 2022.
