5	Definitions	Added "Quarantine"	This term is used in the 2016 Compendium on Animal Rabies Prevention and Control to describe the period of time that exposed domestic animals are to have restricted contact with other animals and people.

43	Education	Removed the requirement for ferrets to be vaccinated against rabies	Ferrets are not required to be vaccinated against rabies in Maine status, so removing ferrets from the list of species requiring vaccination in Maine makes it consistent with state law.
51	Home Quarantine Notice	Added an option for a 4 month quarantine	Per updated Compendium guidance. Replaces 6 month quarantine.
52	Animal Bite Report	Added the Dog Bite (Dunbar) Scale	Added a third page to define the Dog Bite Scale referenced on page two of the bite report.
59	Bat Exclusion	Removed section on netting	The plastic netting is no longer considered a safe method of creating one way valves for excluding bats.
