• Yarmouth Riverfront Woods, Yarmouth, Cumberland County

19.48+/- acre conservation and recreation site with 850' on the Royal River. Primary use of the property will be for hiking, water access, snowmobiling, and habitat protection. This is a fee acquisition by the Town of Yarmouth with a conservation easement held by the Royal River Conservation Trust, and BPL serving as DSA.

Adjacent to the Camden Snowbowl and Mirror Lake, a public drinking water supply, this project will provide the opportunity to expand and improve four-season multi-use recreational access to the region. LMF funds will be used to assist in the acquisition of the 498+/- acres Grassy Pond conservation easement, while the value of the 788+/- acres



easement on Mirror Lake will be applied as match. Both easements will be held by Coastal Mountains Land Trust w/ LMF Project Agreements held by MDIFW as DSA
