MEANG Building 541 Renovate for Boom Operator Simulation System

Sitework, utilities, and installation of foundation to support Boom Operator Simulation System (BOSS) and Relocatable Shelter System (RSS). Construction of approximately 1,500 sf slab-on-grade foundation. Trenching for and installation of conduit for electrical connection from RSS to adjacent building.

The cost of the work is approximately \$ \$150,000. The contract shall designate the Substantial Completion Date on or before *6 October 2023*, and the Contract Final Completion Date on or before *18 October 2023*.

1. Submit bids on a completed Contractor Bid Form, plus bid security when required, all scanned and included as an attachment to an email with the subject line marked "**Bid for MEANG Building 541 BOSS Renovation**" and addressed to the Bid Administrator at: BGS.Architect@Maine.gov, so as to be received no later than **2:30:00 p.m.** on *10 August 2023*.

Bid submissions will be opened and read aloud at the time and date noted above at the Maine Air National Guard, accessible as a video conference call. Those who wish to participate in the call must submit a request for access to BGS.Architect@Maine.gov.

Any bid received after the noted time will not be considered a valid bid and will remain unopened. Any bid submitted by any other means will not be considered a valid bid. The Bid Administrator may require the Bidder to surrender a valid paper copy of the bid form or the bid security document in certain circumstances.

2. The bid shall be submitted on the Contractor Bid Form (section 00 41 13) provided in the Bid Documents. The Owner reserves the right to accept or reject any or all bids as may best serve the interest of the Owner.
3. Bid security *is required* on this project. If noted above as required, the Bidder shall include a satisfactory Bid Bond (section 00 43 13) or a certified or cashier's check for 5% of the bid amount with the completed bid form submitted to the Owner. The Bid Bond form is available on the BGS website.
4. Performance and Payment Bonds *are required* on this project. If noted above as required, or if any combination of Base Bid and Alternate Bids amounts selected in the award of the contract exceeds \$125,000.00, the selected Contractor shall furnish a 100% contract Performance Bond (section 00 61 13.13) and a 100% contract Payment Bond (section 00 61 13.16) in the contract amount to cover the execution of the Work. Bond forms are available on the BGS website.
5. Filed Sub-bids *are not required* on this project.
