Bog Brook Shower and Latrine Renovation

The purpose of this project is to renovate the existing Shower and Latrine Facility to improve its functionality. Project includes demolition of a portion of existing facility. The proposed activity will be of permanent construction and will extend the usable life of the facility. The supporting utilities will need to be upgraded to include: potable water, sewer, underground electrical, and underground communication lines. The Project will increase the square footage from 920 sqft to the authorized 2,500 sqft. This project will also address mold and safety issues. Project shall be executed according to the plans and specifications provided by Oak Point Associates dated 24 August 2023.

The cost of the work is approximately \$ 1,800,000. The contract shall designate the Substantial Completion Date on or before *31 December 2024*, and the Contract Final Completion Date on or before *31 January 2025*.

1. Bids shall be submitted in sealed envelopes plainly marked "**Bid for Bog Brook Shower and Latrine Building Renovation**" and addressed to the Bid Administrator:

The envelope shall contain a completed Contractor Bid Form, plus bid security when required, to be received no later than **2:00:00 p.m.** on **7 September 2023**. Bid submissions will be opened and read aloud at *address listed above* at the time and date noted above.

Any bid submitted after the noted time will not be considered a valid bid and will remain unopened. Any bid submitted by any other means will not be considered a valid bid.

2. The bid shall be submitted on the Contractor Bid Form (section 00 41 13) provided in the Bid Documents. The Owner reserves the right to accept or reject any or all bids as may best serve the interest of the Owner.
3. Bid security *is required* on this project.
If noted above as required, the Bidder shall include a satisfactory Bid Bond (section 00 43 13) or a certified or cashier's check for 5% of the bid amount with the completed bid form submitted to the Owner. The Bid Bond form is available on the BGS website.
4. Performance and Payment Bonds *are required* on this project.
If noted above as required, or if any combination of Base Bid and Alternate Bids amounts selected in the award of the contract exceeds \$125,000.00, the selected Contractor shall furnish a 100% contract Performance Bond (section 00 61 13.13) and a 100% contract Payment Bond (section 00 61 13.16) in the contract amount to cover the execution of the Work. Bond forms are available on the BGS website.
5. Filed Sub-bids *are not required* on this project.
