FINDINGS OF FACT

After review of the file and related materials submitted with regard to the above noted application, pursuant to Title 38, Maine Revised Statutes (M.R.S.) § 590 and 06-096 Code of Maine Rules (C.M.R.) ch. 115, the Maine Department of Environmental Protection (the Department) finds the following facts:

I. Registration

Turning Acquisitions LLC d/b/a Wells Wood Turning & Finishing has requested the transfer of Air Emission License A-1110-71-A-N from Wells Wood Turning & Finishing, Inc. to Turning Acquisitions LLC (TA) through a letter to the Department dated November 28, 2016. Air Emission License A-1110-71-A-N was issued to Wells Wood Turning & Finishing, Inc. on August 6, 2015. The facility is a custom wood turnings manufacturing facility.

All rules, regulations, or statutes referenced in this air emission license refer to the amended version in effect as of the issued date of this license.

II. Transfer Requirements

A. Title, Right, or Interest

In their application, TA submitted copies of property deeds transferring ownership of the facility to TA. The parties have provided sufficient evidence of title, right, or interest in the facility to allow the transfer of the facility's licenses.

B. Technical Capacity and Intent

TA's acquisition of the facility is not expected to result in any significant change in the employees that currently operate the equipment, facilities, and conduct other activities. The facility's regulatory history with the Department demonstrates that the environmental personnel are competent in air pollution control. The information submitted in the application provides sufficient evidence that TA has the technical capacity and intent to comply with their air emission license.
