Air Emission License
Transfer**

FINDINGS OF FACT

After review of the file and related materials submitted with regard to the above noted application, pursuant to Title 38, Maine Revised Statutes (M.R.S.) § 590 and 06-096 Code of Maine Rules (C.M.R.) ch. 115, the Maine Department of Environmental Protection (the Department) finds the following facts:

I. Registration

Southport Yachts, LLC has requested the transfer of Air Emission License A-1122-71-A-N from Southport Boats, LLC to Southport Yachts, LLC through a letter to the Department dated August 23, 2017. Air Emission License A-1122-71-A-N was issued to Southport Boats, LLC on April 18, 2017. The facility is a boat manufacturing facility.

All rules, regulations, or statutes referenced in this air emission license refer to the amended version in effect as of the issued date of this license.

II. Transfer Requirements

A. Title, Right, or Interest

In their application, Southport Yachts, LLC submitted copies of an asset purchase agreement and bill of sale and general assignment transferring ownership of the facility's assets to Southport Yachts, LLC. Southport Yachts, LLC also submitted copies of lease agreements transferring use of part of CPK Manufacturing, LLC's facility to Southport Yachts, LLC. The parties have provided sufficient evidence of title, right, or interest in the facility to allow the transfer of the facility's licenses.

B. Technical Capacity and Intent

Southport Yachts, LLC's acquisition of the facility is not expected to result in any significant change in the employees that currently operate the equipment, facilities, and conduct other activities. The facility's regulatory history with the Department demonstrates that the environmental personnel are competent in air pollution control. The information submitted in the application provides sufficient

evidence that Southport Yachts, LLC has the technical capacity and intent to comply with their air emission license.

D. Certification

Southport Yachts, LLC certifies that there will be no increase in air emissions beyond that provided for in the existing licenses, either in quantity or type.
