# Departmental Findings of Fact and Order Air Emission License Transfer

After review of the file and related materials submitted with regard to the above noted application, pursuant to Title 38, M.R.S.A., Section 590 and Chapter 2 of the Department Regulations, the Department finds the following facts:

# I. Registration

Saco Island West, LLC and Unit 91, LLC have requested the transfer of Air Emission License A-969-71-A-N from SI Development, LLC d/b/a SI Development, LLC & Cutts Island Group to Saco Island West, LLC and Unit 91, LLC through a letter to the Bureau of Air Quality dated July 27, 2007. Air Emission License A-969-71-A-N was issued to SI Development, LLC d/b/a SI Development, LLC & Cutts Island Group on May 30, 2007. The facility consists of heated buildings.

### **II. Transfer Requirements**

### A. Title, Right, or Interest

In their application, Saco Island West, LLC and Unit 91, LLC submitted copies of two assignments of purchase and sale agreement evidencing applicant's right, title and interest in the facility to allow the transfer of the facility's license.

## B. Financial Capacity and Intent

Saco Island West, LLC and Unit 91, LLC state that they each possess the financial capacity to operate the facility in compliance with its air emission license.

### C. Technical Capacity and Intent

Saco Island West, LLC and Unit 91, LLC acquisition of the facility is not expected to result in any significant change in the employees that currently operate the equipment, facilities, and conduct other activities. The facility's regulatory history with the MEDEP demonstrates that the environmental personnel are competent in air pollution control. The information submitted in the application provides sufficient evidence that Saco Island West, LLC and Unit 91, LLC each have the technical capacity and intent to comply with their air emission license.
