8.1 State Standards

According to the Small Wind Certification Application:

An applicant for a certification to construct a small-scale wind energy development must hold at least one public informational meeting in according with the Department's rules, Chapter 2, Section 13.

Public Notice Filing and Certification

Chapter 2 of the Department's Rules requires an applicant to provide public notice for new individual permit applications. In the notice, the applicant must describe the proposed activity and where it is located. "Abutter" for the purposes of the notice provisions means any person who owns property that is BOTH (1) adjoining and (2) within one mile of the delineated project boundary, including owners of property directly across a public or private right of way.

- 1. **Newspaper:** The Notice of Intent to File must be published in a newspaper circulated in the area where the activity is located. The notice must appear in the newspaper within 30 days prior to the filing of the application with the Department. The attached Notice of Intent to File form may be used, or an alternate format containing identical information, for newspaper publication and certified mailing.
- 2. **Abutting Property Owners:** A copy of the Notice of Intent to File must be sent by certified mail to owners of all properties abutting the activity. The names and address of abutters can be obtained from the town tax maps or local officials. Abutters must receive notice within 30 days period to the filing of the application with the Department.
- 3. **Municipal Office:** A copy of the Notice of Intent to File <u>and</u> a **duplicate of the entire application** must be provided to the Municipal Office of any municipality in which any portion of the project is located.

8.2 Public Informational Meeting

RoxWind hosted a Public Informational Meeting on March 7, 2018. The meeting was noticed in the Sun Journal and the Rumford Falls Times on February 21, 2018. A copy of the notices for the Public Informational Meeting as published in the local newspapers is included in Exhibit 8-A. RoxWind also sent certified mailings to abutters to the Project. Abutters to the Project were determined in consultation with the Town and through review of the Tax Maps. Abutters to the Project who reside outside of the Town's boundary in Rumford were determined by examining the Town of Rumford's tax maps and Real Estate Tax Commitment Book – 2018. Twenty-one (21) abutters were identified and certified mail was sent to each abutter's attention, at the address available from the respective Towns. In addition, notice of the Public Informational Meeting was sent directly to the Town via certified mail. The certified mailings were sent the week of February 19th-23rd; all in excess of ten (10) days prior to the Public Informational Meeting. A list of property owners who were sent notice of the Public Informational Meeting and a copy of such notice is included in Exhibit 8-B.

Outside of RoxWind's notice obligations for the Public Informational Meeting, the Town independently posted details about the Public Informational Meeting on the Town Hall's sign, viewable from Roxbury Road (Exhibit 8-C).

The meeting was attended by approximately 12 residents of Roxbury. In addition, representatives from Stantec (Brooke Barnes, Principal, Environmental Services) and Epsilon (Rob O'Neal, Managing Principal) attended the meeting to present their respective firm's studies and to answer questions from the public. At the meeting, RoxWind, with its consultants, presented information and answered questions regarding the details of the Project, its anticipated environmental impacts, and opportunities for future comment. The format of the meeting was a combination of a group question and answer session and an open house. RoxWind displayed visuals including depictions of flicker and sound impacts, photosimulations, and site plans. The meeting formally commenced with a group question and answer session. After the group questions were answered, residents were invited to visit each display, ask questions, and, with regard to the flicker and sound displays, identify where their homes are located in relation to the Project. Handouts were available at the meeting, including the Project's website, anticipated environmental impacts, permitting requirements, and the Department's information sheet regarding public participation. A copy of the handouts is included as Exhibit 8-D.

8.3 Notice of Intent to File

The Notice of Intent to File was published in the Sun Journal and the Rumford Falls Times on February 21, 2018. A copy of the Notices of Intent to File as published in the local newspapers is included in Exhibit 8-A. Similar to the Public Informational Meeting (Section 8.2) RoxWind also sent certified mailings to neighbors listed in Exhibit 8-B and provided a copy of the Notice of Intent to File. The certified mailings were sent the week of February 19th-23rd and the first notices delivered were on February 22, 2018.



Public Informational Meeting

The proposed project is a wind energy generation project consisting of 4 wind energy generators and their related infrastructure on North Twin Mountain (the Project). The wind turbines proposed are manufactured and commissioned by General Electric (GE) and will be located on 85 meter towers with 65 meter long blades (for a total proposed tip height of 150 meters). The Project is designed to conform to the State's Department of Environmental Protection (DEP) Application for Siting Certification and Natural Resource Protection Act Permit for Small-Scale Wind Energy Developments (SWC).

<u>Environmental Impacts:</u> Among other requirements to apply under the Small Wind Certification, the Project must occupy 20 acres or less and create 3 acres or fewer of new impervious surfaces. After the Project is constructed, the site will be strategically revegetated to decrease the final Project footprint while maintaining safe and appropriate site access. The Project is expected to have a relatively minor environmental impact due to its small size and location. It is proposed on a parcel that has been heavily logged and will utilize the existing access road, with improvements, to access the site.

For each of major discipline to be studies, RoxWind has contracted with professional consulting firms in support of its application, including:

<u>Civil Engineering:</u> Stantec Inc. completed soil surveys; designed site plans including erosion control and construction plan; completed wildlife survey following guidance from Maine Department of Inland Fisheries and Wildlife (MDIFW): **No species of concern identified by MDIFW was found to be present on the site.**



<u>Sound and Flicker Analysis:</u> *Epsilon Associates, Inc.* completed flicker and sound analysis for Project. *No surrounding residence should exceed 30-hours of flicker per year from the Project. No surrounding residence shall exceed 42 dBA (Maine night time sound limit) of sound from the Project.*



<u>Wetlands and Site Visibility:</u> *Kleinschmidt Associates* investigated the site for vernal pools, wetlands and stream delineations; verified site visibility from surrounding parcels. *Less than a quarter acre of wetland fill in multiple locations and less than 500' of culverts for intermittent streams.*

<u>Visual Impact Assessment:</u> *Terry J. Dewan & Associates* – completed visual impact assessment and created photosimulations.



The full flicker and sound impact maps, site plans, and photosimulations are available for your viewing during tonight's meeting.

Local Permits and Approvals:

The Project submitted a Building Permit Application to the Planning Board for approval on February 22, 2018.

State Permits and Approvals:

The Project requires a SWC from DEP. In addition, the Project has identified the following DEP filings that may be applicable: Natural Resources Application Form and Narrative and a Permit by Rule Notifications.

In addition, the Project has worked with MDIFW to draft an incidental take permit plan that will limit the Project's operations during periods of time when bats are presumed to be active.

Federal Permits and Approvals:

The Project received determinations of no hazard from the Federal Aviation Administration in July 2017. In addition, the Project is evaluating the need to file an application with the US Army Corps of Engineers.

Public Participation in DEP Process:

Public Participation in the Licensing Process

SUMMARY

Maine law charges the Commissioner of the Department of Environmental Protection (D.E.P.) with evaluating license applications for many different activities that affect Maine's environment. Individuals and legal entities may participate at various points during license application processing. Individuals must recognize that the Commissioner's charge may, under certain circumstances, be overtaken by the Board of Environmental Protection (Board). This INFORMATION SHEET, in conjunction with consulting statutory and regulatory provisions referred to in this document, will assist with your understanding of the potential opportunities for participation in the Commissioner's process; other specific provisions that apply to the Board are not addressed in this INFORMATION SHEET. A failure to participate during the licensing process will result in a person's only option for influence over that decision being the filing of an appeal. D.E.P.'s *Rules Concerning the Processing of Applications and Other Administrative Matters (Chapter 2)*, 06-096 CMR 2, was promulgated, in part, to provide guidance on this process.

- 1. PUBLIC ACCESS TO INFORMATION. Records submitted to D.E.P. are generally available to the public under Maine's Freedom of Access Law, 1 M.R.S.A. §§ 401-410. Other than portions claimed to be confidential by law when submitted to D.E.P., all license application materials are readily available for review and copying at our offices in Augusta, Portland, Bangor, and Presque Isle.
- 2. PUBLIC NOTICE. Maine law requires applicants to publicly make known their intent to submit an application to D.E.P. It is the responsibility of an individual who is interested in following or participating in the license decision-making process to act after seeking out that notice or, if you are an abutter, to act when noticed directly by mail.
 - **A. Public Informational Meetings.** Informational meetings are held by persons prior to submitting a licensing application to D.E.P. for the purpose of informing the public about an anticipated project. These meetings are held at a location near to a proposed project and are by design open to the public. Abutters to the anticipated project location receive notice in the mail of the meeting time and location, and notice is also published in newspapers serving the area of the project.
 - **B.** Application Filing. Prior to filing an application with D.E.P., abutters to the project location receive notice in the mail of the anticipated filing date, and it is also published in newspapers serving the area of the project.
- 3. INTERESTED PERSONS. Individuals can acquire materials submitted to D.E.P., attend public informational meetings, provide comments and request that a public hearing be held on a filed application, request that the Board take jurisdiction over an application, and provide comments on a draft decision.
 - **A. Maximum Participation.** Participation in a D.E.P. licensing decision to the maximum extent possible requires a person to submit a written request stating his or her desire to acquire material related to an application. The individuals who do are known as "interested persons." Once a request is filed, interested persons will be provided with the opportunity to inspect and copy materials on file at D.E.P.; they also receive direct notice of public informational, pre-application and pre-submission meetings, and public hearings. The timing of an interested person's request to be part of the process will determine the number of events potentially available to him or her.

- **B.** Public Informational Meetings. Informational meetings are held to inform the public about environmental impacts that are anticipated from a project. Interested persons may ask questions at such a meeting. Questioners should be aware that answers may not be available during the meeting.
- C. Pre-application and Pre-Submission Meetings. D.E.P. often meets with potential applicants to identify regulatory and processing issues that need consideration. Pre-application and presubmission meetings will typically not be attended by interested persons, in part because such a meeting is not, by law, a "public proceeding" freely open to attendance under Maine's Freedom of Access Law. Although the decision to allow individuals other than an applicant to attend is D.E.P.'s to make, interested persons invited to attend such a meeting should expect only to observe, since public input cannot be received at this time in the licensing process.
- **D. Application Comments.** Interested persons and any other member of the public may submit written comments, including technical information, at any time during the course of an application's processing. It is in that person's interest to submit information early in the process in order to ensure adequate time for consideration by the D.E.P. staff member evaluating the application.
- **E. Draft Order Comments.** Interested persons will receive the Commissioner's draft licensing decision at least five (5) working days prior to final action. Written comments may be submitted on that draft decision. Reasonable notice of when the Commissioner anticipates issuing a final decision on the draft order will also be provided to interested persons.
- **F. Public Hearing Requests.** People may request that a public hearing be held on a filed application within 20 days after its acceptance as complete for processing by D.E.P. Such a request must satisfy requirements found in Section 7 of Chapter 2. The Commissioner will typically order that a hearing be held where credible conflicting technical information appears to exist regarding a licensing criterion.
- **G. BEP Jurisdiction Requests.** People may request that the Board assume jurisdiction over a filed application within 20 days after D.E.P. accepts it as complete for processing. Such a request must satisfy Section 17 of Chapter 2. Board jurisdiction is not available for windpower development projects.

PUBLIC NOTICE FILING AND CERTIFICATION

Chapter 2 of the Department's Rules requires an applicant to provide public notice for new individual permit applications. In the notice, the applicant must describe the proposed activity and where it is located. "Abutter" for the purposes of the notice provision means any person who owns property that is BOTH (1) adjoining and (2) within one mile of the delineated project boundary, including owners of property directly across a public or private right of way.

- 1. **Newspaper:** The Notice of Intent to File must be published in a newspaper circulated in the area where the activity is located. The notice must appear in the newspaper within 30 days prior to the filing of the application with the Department. The attached Notice of Intent to File form may be used, or an alternate format containing identical information, for newspaper publication and certified mailing.
- 2. **Abutting Property Owners:** A copy of the Notice of Intent to File must be sent by certified mail to the owners of all properties abutting the activity. The names and addresses of abutters can be obtained from the town tax maps or local officials. Abutters must receive notice within 30 days prior to the filing of the application with the Department.
- 3. **Municipal Office:** A copy of the Notice of Intent to File and a **duplicate of the entire application** must be provided to the Municipal Office of any municipality in which any portion of the project is located.

ATTACH a list of the names and addresses of the owners of abutting property.

CERTIFICATION

By signing below, the applicant or authorized agent certifies that:

- 1. A Notice of Intent to File was published in a newspaper circulated in the area where the project site is located within 30 days prior to filing the application;
- 2. A certified mailing of the Notice of Intent to File was sent to all abutters within 30 days prior to the filing of the application;
- 3. A certified mailing of the Notice of Intent to File, and a duplicate copy of the application was sent to the town office of the municipality in which the project is located; and
- 4. Public notice was provided and a Public Informational Meeting was held, in accordance with the Department's Chapter 2, Rules Concerning the Processing of Applications, Section 13, prior to filing the application. Notice of the meeting was sent by certified mail to abutters and to the town office of the municipality in which the project is located at least ten days prior to the meeting. Notice of the meeting was also published in a newspaper circulated in the area where the project site is located at least seven days prior to the meeting.
