

ImmPact DX HL7 testing requirements and expectations

- The EMR test region will closely represent the EMR's production region.
- The EMR will map the codes, for required fields, provided in Appendix A of the Maine HL7 spec.
- The EMR will map the CVX codes provided by the State.
- The EMR will demonstrate the ability to send **ALL** VFC Eligibility codes (OBX-5).
- The EMR will demonstrate the ability to send Non-administered.
- All patients sent into the IIS test region will be fictitious. **Do not send real PHI.**
- All locations that will interface with the Maine IIS will be tested.
- Each location will send messages until MIP confirms state requirements have been met.
- The expectation is that Reminder Recall will be allowed (02 any method) unless indicated differently by patient or guardian. PD1-11 empty will be treated as 02.
- The expectation is that Sharing will be allowed (protection indicator = N) unless indicated differently by patient or guardian. PD1-12 empty will be treated as N
- Opt-Out – Demonstrate *do not send* capability. Patients who opt-out by submitting a non-participation form to the State have their record locked in the IIS user interface. Any HL7 messages sent for the patient will unlock the record.

Details of required fields:

MSH-4 will contain either the organization code or organization id of the sending location – codes are supplied by the State of Maine

MSH-7 should be data type TS_Z with precision to second and time zone

MSH-22 will contain the organization id of the location administering the immunization – code is supplied by the State

PID – Messages with first name Girl or first name Baby will be rejected. If a patient is unnamed send NO FIRST NAME or NOFIRSTNAME in PID-5. If patient is un-name, mother's name is required in PID-6

PID-10 and **PID-22** – if included use codes supplied in Appendix A of the Maine HL7 spec

PID-11 – Demonstrate ability to send county. The format is the county name spelled out or Maine FIPS code

PID-13 – if supplied by patient, include. Format is PID-13.6 three-digit area code; PID-13.7 seven digit phone number.

PD1-11 will be 02, or empty, unless patient declines inclusion in Reminder/Recall. 01 will prevent patients from being returned in the result of a Reminder/Recall report run by users in the IIS.

NOTE: if **PD1-11** is empty, the IIS will default to 02.

PD1-12 – If Protection Indicator is set to Y, other organization users get a warning that the patient does not wish to share. Protection Indicator is set to Y will result in NF if queried (bi-directional). This is not a patient opt-out

NOTE: if **PD1-12** is empty, the IIS will default to N.

NK1 – Send next of kin/responsible person information. If none is given by the patient use SEL in NK1-3 and same name/address info from PID.

RXA-5.1 must contain the CVX code of the vaccine administered

RXA-5.3 must be CVX

RXA-6 must contain the correct dose amount in milliliters if doing dose decrementing

RXA-7 must contain the units if the immunization is administered

RXA-11.4 will contain the organization id of the location administering the immunization – code is supplied by the State. This code is linked to the inventory for dose decrementing.

RXA-16 (dose decrementing) must match the expiration date of the lot in ImmPact. This can affect the ability to update in the des-dec fix tool

RXR1 will contain the administration route

RXR2 will contain the body site

OBX – Do not Send Vaccine Funding Source (30963-3)

NOTE: but if sent it MUST precede the OBX for Vaccine eligibility (6994-7)

OBX – Vaccine eligibility (6994-7) is required

OBX – VIS revision dates in the IIS are updated per the CDC website

NOTE: Bar coded VIS format is not supported. Must be 3 OBX statements as illustrated above.

Details of required fields:

MSH-4 will contain either the organization code or organization id of the sending location – codes are supplied by the State of Maine

MSH-7 should be data type TS_Z with precision to second and time zone

MSH-22 will contain the organization id of the location administering the immunization – code is supplied by the State

PID – Messages with first name Girl or first name Baby will be rejected. If a patient is unnamed send NO FIRST NAME or NOFIRSTNAME in PID-5. If patient is un-name, mother's name is required in PID-6

PID-10 and **PID-22** – if included use codes supplied in Appendix A of the Maine HL7 spec

PID-11 – Demonstrate ability to send county. The format is the county name spelled out or FIPS code

PID-13 – if supplied by patient, include. Format is PID-13.6 three-digit area code; PID-13.7 seven digit phone number.

PD1-11 will be 02 unless patient declines inclusion in Reminder/Recall. 01 will prevent patients from being returned in the result of a Reminder/Recall report run by users in the IIS.

NOTE: if **PD1-11** is empty, the IIS will default to 02.

PD1-12 – If Protection Indicator is set to Y, other organization users get a warning that the patient does not wish to share. Protection Indicator is set to Y will result in NF if queried (bi-directional). This is not a patient opt-out

NOTE: if **PD1-12** is empty, the IIS will default to N.

NK1 – Send next of kin/responsible person information. If none is given by the patient use SEL in NK1-3 and same name/address info from PID.
