Reminder: Tdap for 7th Grade Entry

The Maine school age immunization requirements have recently changed to include 1 Tdap as a required vaccine for 7th grade entry. Make sure your 7th grade patients are up-to-date with Tdap, as well as with their HPV and meningococcal vaccines.

2017-2018 Influenza Vaccine Availability and Ordering

The Maine Immunization Program (MIP) is pleased to announce that influenza vaccine will be available for you to order through ImmPact on September 5.

MIP is supplying seasonal influenza vaccine for all children in Maine, ages 6 months through 18 years. <u>MIP will not be supplying influenza vaccines to</u> <u>adults 19 years or older regardless of health or</u> <u>insurance status</u>.

To ensure your facility will be eligible to place your order, please guarantee that the following are up-to-date within ImmPact:

- 2017 Provider Agreement
- Current ImmPact User Agreement
- Current submission of monthly temperature logs
- Current reconciliation of inventory

As stipulated in your Immunization Provider Vaccine Agreement, we ask that you order only the amount of vaccine that you know you will be administering for a 6-week time period.

<u>Please note</u>: Influenza vaccine ordered for the 2017-2018 season will be subject to the Vaccine Replacement Procedure.

The Vaccine Information Statement (VIS) did NOT change. Please continue to use the 8-7-2015 edition.

U. S. CDC Reports on Merck Hepatitis B Vaccine Shortage

U.S. CDC recently posted the following notice on its Current Vaccine Shortages & Delays web page:

Merck is not currently distributing its adult Hepatitis B vaccine (Recombivax HB) and does not expect to be distributing adult Hepatitis B vaccine between now and the end of 2018. Additionally, Merck anticipates that its pediatric Hepatitis B (Recombivax HB) vaccine will be unavailable between early August 2017 and early 2018. Merck's supply of the dialysis formulation of Hepatitis B vaccine, however, is not affected and is expected to remain available. GlaxoSmithKline has sufficient supplies of adult and pediatric Hepatitis B vaccines (Engerix-B) to address these anticipated gaps in Merck's supply of adult and pediatric Hepatitis B vaccines during these time periods; however, preferences for a specific presentation (i.e., vial versus syringe) may not be met consistently during this time.

Age Eligibility for Vaccines

Children under the age of 19 are eligible for publicly-supplied vaccine from the State of Maine. This includes children up to age 18 years, 364 days.

Types of Site Visits

Types of Site Visits

Immunization Program and what they are for. There are four types of site visits:

VFC (Vaccines For Children) Compliance Visit: This visit assesses program requirements (such as program eligibility), assesses storage and handling practices, and provides education.

AFIX (Assessment, Feedback, Incentives, and eXchange) Visit: This is an education visit. AFIX is a continuous quality improvement strategy to improve immunization rates at the provider level.

Unannounced Storage and Handling Visit: This unscheduled "pop-in" visit assesses storage and handling techniques and provides education.

Education/OrientationVisit: This visit is for new practices and staff, to orient new staff to MIP and its programs and policies. To schedule an education/orientation visit, contact Celeste Poulin at 207-287-4466.
