Thank you for the request for approval of changes to the Maine Coastal Management Program. You requested that the changes described below be incorporated as routine program changes (RPCs), pursuant to Coastal Zone Management Act (CZMA) regulations at 15 C.F.R. part 923, subpart H, and the National Oceanic and Atmospheric Administration's (NOAA's) Office for Coastal Management's *Program Change Guidance (July 1996)*. The request, dated August 10, 2017, was received on August 24, 2017. The original decision deadline of September 23, 2017, was extended to December 8, 2017.

Based on our review of your submission, we concur that the changes are RPCs and we approve the incorporation of the changes to the Maine Coastal Management Program. Approved changes to enforceable policies of the Maine Coastal Management Program will apply after notice is published of this approval pursuant to 15 C.F.R. § 923.84(b)(4) and the Office for Coastal Management's Addendum to the July 1996 Program Change Guidance (November 2013). Please include in the public notice the list of changes provided in this letter, and send a copy of the notice to the Office for Coastal Management.

For the purposes of the record, it is noted that technical corrections have been made within the Table of Approved Changes to correct statutory citations in the state's submission. For the addition of certain exceptions to the requirements pertaining to subdivisions, the citation of 12 M.R.S. §4402(6) has been corrected to 30-A M.R.S. §4402(6). Also within the rules for subdivisions, an incorrect citation was found for the changes to definitions. The incorrect citation 12 M.R.S. §4401(4)(H-2) has been corrected to 30-A §4401(4)(H-2). Among the rule changes, the citation to exceptions pertaining to certain activities as they relate to endangered bat species that were cited as CMR 01-137, ch. 8.06 has been corrected to CMR 09-137, ch. 8.06. The Office for Coastal Management has found that these errors in the submission package are minor and of no consequence. Please note these corrections in the public notice of the approval of these program changes.
