Thank you for the Maine Coastal Management Program's January 14, 2014 request that changes to the Department of Environmental Protection (DEP) and Land Use Planning Commission (LUPC) rules be incorporated into the Maine Coastal Management Program (CMP). You requested that the changes described below be incorporated as routine program changes (RPCs), pursuant to Coastal Zone Management Act (CZMA) regulations at 15 C.F.R. part 923, subpart H, and Office of Ocean and Coastal Resource Management (OCRM) Program Change Guidance (July 1996). OCRM received the request on January 15, 2014, and OCRM's decision deadline is February 12, 2014.

Based on our review of your submission, we concur, with the exceptions described below, that the changes are RPCs and we approve the incorporation of the changes as enforceable policies of the Maine CMP. Federal Consistency will apply to the approved changes to enforceable policies only after you publish notice of this approval pursuant to 15 C.F.R. § 923.84(b)(4) and OCRM's *Addendum to the July 1996 Program Change Guidance (November 2013)*. Please include in the public notice the list of changes provided in this letter, and please send a copy of the notice to OCRM.

CHANGES APPROVED

QUALIFICATIONS

In the review of the State's submission, it was noted that the current language of Ch. 692 of the DEP rules providing a definition of the term "person" for the purposes of those subject to the requirements for oil storage facilities includes the United States and agencies of the United States. Unless Congress has expressly conferred upon states the authority to regulate federal agencies in certain matters, states have no power to do so and the CZMA makes no exception to this. Although this program change submission does not include changes to the definition of "person" in Ch. 692, we want to make clear that our approval of Ch. 692 as revised does not confer upon the State authority to regulate federal agencies.





As a general qualification, we also note that States may not incorporate enforceable policies by reference. If an approved enforceable policy refers to another regulation, policy, standard, guidance, or other such requirement or document (hereinafter "referenced policy"), the referenced policy itself must be submitted to and approved by OCRM as an enforceable policy in order to be applied under the federal consistency review provisions of the CZMA. Therefore, no requirement or document referenced in these approved enforceable policies may be applied for federal consistency unless that requirement or document has separately been approved by OCRM.

PUBLIC AND FEDERAL AGENCY COMMENTS

OCRM received no comments on this RPC submission.
