- Class D** (Motor vehicles with a gross vehicle weight rating of 10,001 or more pounds, vehicles designed to transport more than 15 passengers, vehicles used to transport hazardous materials in quantities required to be placarded or commercial vehicles with a gross combination weight rating of 10,001 pounds or more, except school buses.) (Must also have Class A.)
- Class E** (Any motor vehicle required to be registered in Cumberland County which is subject to the enhanced inspection described in 29-A MRSA § 1751.) (Must also have Class A.)
