## **EXECUTIVE DIRECTOR'S REPORT**

In January 2022 there were (5) shipments of machines and/or associated equipment shipped to or from licensed facilities. On-site inspectors completed (750) observations and (30) checklists. There were (8) self-exclusions. There were (7) minor incidents that will continue to be monitored from our activity log. There were no patron complaints and no formal complaints of potential violations placed on the dashboard.

For the month of January 2022, the Unit has identified an increase of 43.5% in total tax revenue for both facilities versus January 2021. Year to date obviously the Unit has identified the same increase of 43.5% versus last year at the same time.

Oxford reported a 7.9% win for the month of January from slots and a 22.4% win from table games. Oxford's payback percentage was 92.1%. Average gross win per machine was \$196.43. Hollywood reported a 9.6% average win for the month of January from slots and a 26.2% win from table games. Hollywood's payback percentage was 90.4%. Average gross win per machine was \$158.07.

In February 2022 there were (2) shipments of machines and/or associated equipment shipped to or from licensed facilities. On-site inspectors completed (670) observations and (32) checklists. There were (6) self-exclusions. There were (6) minor incidents that will continue to be monitored from our activity log. There were no patron complaints and no formal complaints of potential violations placed on the dashboard.

For the month of February 2021, the Unit has identified an increase of 58.4% in total tax revenue for both facilities versus February 2020. Year to date the Unit has identified an increase of 51.2% versus last year at the same time.

Oxford reported an 8.4% win for the month of February from slots and a 24.0% win from table games. Oxford's payback percentage was 91.7%. Average gross win per machine was \$260.16. Hollywood reported a 9.4% average win for the month of February from slots and a 22.6% win from table games. Hollywood's payback percentage was 90.6%. Average gross win per machine was \$202.03.

Bill LD 1743 passed out of committee on the definition change from electronic facsimile to electronic table game. LD 1745 passed out of committee on the option of a 3-year license for individual employee licenses at renewal.

On March 7, Commissioner Sauschuck appeared before the Joint Standing Committees on Appropriations and Financial Affairs and Veterans and Legal Affairs with a request for \$66,370.00 to go forward with online applications for casino employee individuals. This will allow for temporary licenses to be issued the same day the application and fee are accepted. On March 14, the VLA committee passed the initiative.

Director Champion brought to the attention of the Board that he is directing Det. Armstrong's position differently from the past in that criminal conduct taking place at the casinos should be directed toward local law enforcement and district attorney offices by the licensee as a complainant or a patron as the complainant.

The Unit has been reviewing the comments from the publication of rulemaking regarding the proposed changes to Board Rules, Chapter 5, Appendix A, the Board's Minimal Internal Control Standards. Due to the length of the review and considering time, Director Champion would like to request a second meeting in April to just review these comments before the regularly scheduled meeting of April 19.

**STATE POLICE REPORT**

Detective Don Armstrong reported for the past 2 months there were 42 new and 68 renewal investigations completed, with 49 still pending. There were 8 Ticket-In, Ticket-Out (TITO) incidents; all but 2 have been taken care of. Several counterfeit bills have been discovered and given to the Secret Service. There were 19 calls for service in Bangor and 16 in Oxford for the local police department.
