Re: Request by Josh McClenney for Waiver of Late-Filing Penalty Due to Late June Lobbying Report

---

Josh McClenney, the lobbyist for American Council for an Energy Efficient Economy, was required to file his June Lobbying Report no later than Thursday, June 15, 2023, but it was not until June 22<sup>nd</sup>, 7 days late. The preliminary penalty for the late report is \$100. Mr. McClenney requests a waiver of the penalty.

### **LEGAL REQUIREMENTS**

When the Legislature is in session, registered lobbyists shall file with the commission, no later than 11:59 p.m. on the 15<sup>th</sup> calendar day of each month, a report concerning the lobbyist's activities for the previous month regarding each client. 3 M.R.S. § 317(1). If a lobbyist is late in filing a monthly report, the amount of the penalty is determined by how late the report was filed. If the report is filed within 24 hours of the deadline, the penalty is \$50, otherwise the penalty is \$100. The penalty will then increase another \$100 for every additional month the report is late. 3 M.R.S. § 319(1).

### **DISCUSSION**

Mr. McClenney registered as a lobbyist with the Commission on May 3, 2023. The first report due for his lobbying activity was the June Lobbying Report, to disclose May lobbying activity. The report was due June 15<sup>th</sup>. On June 14<sup>th</sup>, Mr. McClenney called and left Political Committee & Lobbyist Registrar Emma Burke a voicemail stating he had attempted to file his first report, but had accidentally filed the short form version instead, which states the lobbyist had no activity in the reporting month. On the morning of June 14<sup>th</sup>, Ms. Burke unfiled the short form version of the June Lobbying Report, and emailed Mr. McClenney stating she had done so, and he would be able

to file the long form version of his report. Mr. McClenney responded thanking Ms. Burke about an hour later.

On June 15<sup>th</sup>, Ms. Burke sent two emails to Mr. McClenney, whose June Lobbying Report had not yet been filed correctly, reminding him of the filing deadline. The second email notified him she would be on vacation from June 18<sup>th</sup> through June 20<sup>th</sup> and would not be able to provide notice to lobbyists with unfiled reports during that time. When Ms. Burke returned to work on June 21<sup>st</sup>, she sent another email to Mr. McClenney notifying him he had not filed his June Lobbying Report yet. Mr. McClenney, who had also been on vacation, responded to Ms. Burke's email on June 22<sup>nd</sup>, stating his apologies. Mr. McClenney's June Lobbying Report for American Council for an Energy Efficient Economy was filed on June 22, 2023, 7 days late.

Based on the statute for calculating late-filing penalties for monthly lobbying reports, the preliminary penalty amount is \$100.

In his waiver request, Mr. McClenney states he attempted to file the report on time on June 14<sup>th</sup>, made the mistake with the short form, and then attempted to file again on the same day. He believed he had filed, but realized he may have simply saved the report instead of filing it.

### **STAFF RECOMMENDATION**

Lobbyists are a unique filer with the Commission, as they are compensated employees or independent contractors of their client, and their monthly reports are part of their paid work. Reports are always due at least two weeks after the end of the reporting month, creating a large window of time for reports to be timely filed in. In the case of Mr. McClenney, there are multiple factors to consider. He is a new lobbyist in Maine, and this report was his first using Maine's eFiling system. However, he did not log into the system or attempt to file a report until June 13<sup>th</sup>, 40 days after he was allowed access to eFiling. For lobbyist penalties, "The commission may waive the fine or penalty in whole or in part if [it] determines the failure to...report was due to mitigating circumstances or the fine or penalty is disproportionate to the level experience of the lobbyist or the harm suffered by the public from the late...report. [...] 'mitigating circumstances' means:

- A. A valid emergency determined by the commission, in the interest of the sound administration of justice, to warrant the waiver of the fine or penalty in whole or in part;

B. An error by the commission; or

C. Circumstances determined by the commission to warrant the waiver of the fine or penalty in whole or in part, based upon relevant evidence presented that a bona fide effort was made to file the report in accordance with this chapter, including, but not limited to, unexplained delays in Internet service.” 3 M.R.S. § 319(1)

Since 2018, the Commission has heard seven waiver requests for lobbyists requesting a waiver of penalties for a late-filed monthly report. Four of the penalties, three for \$50 and one for \$100, were not waived. Three of the penalties, all of \$100, were reduced by half to \$50. The reasons for these waiver requests were illness, issues with a merged username, and confusion regarding the filing of a non-session waiver.

The Commission staff does not recommend a reduction in the preliminary penalty of \$100 because it is proportionate to the violation of filing a lobbyist report seven days late by someone who is required to make the disclosure as part of their paid occupation. There was an attempt to file the report, but the failure of the filing was due to Mr. McClenney, and not internet or website service issues. He was not ill, had no issues logging in, and was aware he was required to file a report. Nevertheless, if the Commission is persuaded to provide some relief after hearing from Mr. McClenney at the August 23<sup>rd</sup> meeting, the Commission has the discretion to grant a partial waiver which has sometimes been the outcome when candidates have entered data into the Commission’s eFiling system but made an error in clicking on the “File” button.

The Commission staff has made a preliminary determination a penalty of **\$100** applies for the late filing of the 2023 June Lobbying Report for your client American Council for an Energy Efficient Economy. 3 MRS § 319. The report was due on June 15, 2023, but was not filed until June 22, 2023.

## §317. Reports

A registered lobbyist shall file a report for each month that the Legislature is in session on forms prescribed or approved by the commission, even if no lobbying has been performed or compensation or reimbursement for expenses received for the month. [PL 2019, c. 587, §12 (RPR); PL 2019, c. 587, §18 (AFF).]

**1. Monthly session reports.** During the period in which the Legislature is in session, a registered lobbyist shall file with the commission, no later than 11:59 p.m. on the 15th calendar day of each month, a report concerning the lobbyist's activities for the previous month regarding each employer.

The monthly report must contain the following information:

- A. The month to which the report pertains; [PL 1979, c. 632, §2 (RPR).]
- B. The name and address of the lobbyist and employer; [PL 1979, c. 632, §2 (RPR).]
- C. The names of the individuals who lobbied during the month; [PL 1979, c. 632, §2 (RPR).]
- D. The total amount of compensation the lobbyist and lobbyist associates received or expect to receive for lobbying during the month. The amount of compensation for lobbying officials in the legislative branch, officials in the executive branch and constitutional officers must be reported separately.

In the case of a lobbyist or lobbyist associate who is a regular employee of the employer, the amount of compensation must be computed by multiplying the number of hours devoted to the preparation of documents and research for the primary purpose of influencing legislative action and to lobbying by the employee's regular rate of pay based on a 40-hour week; [PL 2019, c. 587, §13 (AMD); PL 2019, c. 587, §18 (AFF).]

E. The total amount of expenditures made or incurred by the lobbyist and lobbyist associates during the month for purposes of lobbying for which they have been or expect to be reimbursed. The amount of expenditures for lobbying officials in the legislative branch, officials in the executive branch and constitutional officers must be reported separately; [PL 2019, c. 587, §13 (AMD); PL 2019, c. 587, §18 (AFF).]

E-1. When expenditures made or incurred for the purposes of grassroots lobbying exceed \$2,000 during the month that is the subject of the report, the specific dollar amount of expenditures for grassroots lobbying made or incurred during the month by a lobbyist, lobbyist associate or employer, with separate totals for expenditure categories as determined by the commission, and the legislative actions that are the subject of the grassroots lobbying. Salaries paid to the employer's regular employees are not expenditures for the purposes of this paragraph and are exempt from disclosure under this paragraph; [PL 2019, c. 599, §3 (AMD); PL 2019, c. 599, §5 (AFF).]

F. The total amount of expenditures by the lobbyist and lobbyist associates on behalf of the employer for which they have been or expect to be reimbursed and by the employer directly to or on behalf of one or more covered officials, including members of the official's immediate family; [PL 2019, c. 587, §13 (AMD); PL 2019, c. 587, §18 (AFF).]

G. For each expenditure of \$25 or more reported under paragraph F, the person making the expenditure and the date, amount and purpose of the expenditure and the name of the covered official or official's immediate family member on whose behalf the expenditure was made; [PL 2019, c. 587, §13 (AMD); PL 2019, c. 587, §18 (AFF).]

G-1. If the total cost for covered officials and the officials' immediate family members to attend an event paid for by the employer or by the lobbyist, lobbyist associate or lobbying firm on the employer's behalf is \$250 or more, the date and a description of the event, a list of the names of covered officials and the officials' immediate family members in attendance and the total cost for

the covered officials and the officials' immediate family members to attend the event; [PL 2019, c. 587, §13 (AMD); PL 2019, c. 587, §18 (AFF).]

H. A list of each legislative action by Legislative Document number, specific issue, nomination or other matter in connection with which the lobbyist is engaged in lobbying; [PL 2007, c. 630, §14 (AMD).]

I. A list specifically identifying each legislative action for which the lobbyist and lobbyist associates were compensated or expect to be compensated, or expended in excess of \$1,000 for lobbying related to those actions and a statement of the amounts compensated or expended for each; and [PL 2019, c. 587, §13 (AMD); PL 2019, c. 587, §18 (AFF).]

J. A list of all of the employer's original sources and a statement of the dollar amounts contributed or paid by the original sources to the employer. If the original source is a corporation formed under Title 13 or 13-C or former Title 13-A, nonprofit corporation formed under Title 13-B or limited partnership under Title 31, the corporation, nonprofit organization or limited partnership, not the individual members or contributors, must be listed as the original source. [PL 2009, c. 282, §5 (AMD).]

[PL 2019, c. 587, §13 (AMD); PL 2019, c. 587, §18 (AFF); PL 2019, c. 599, §3 (AMD); PL 2019, c. 599, §5 (AFF).]

**1-A. Lobbyist expenditure reports.** A lobbyist or lobbyist associate who makes an expenditure directly to or on behalf of a covered official or a member of the covered official's immediate family that is not reportable under subsection 1, paragraphs F, G or G-1 shall file a report pursuant to this subsection. If such an expenditure is made by a lobbying firm, a lobbyist or lobbyist associate from that lobbying firm shall report the expenditure.

A. A report under this subsection is required if:

- (1) The total amount of expenditures directly to or on behalf of covered officials and their immediate family members is more than \$300 in a calendar month; and
- (2) The lobbyist or lobbyist associate has not been and does not expect to be reimbursed by any employer. [PL 2019, c. 587, §14 (NEW); PL 2019, c. 587, §18 (AFF).]

B. The report must include:

- (1) The date of the expenditure;
- (2) The name and address of the lobbyist, lobbyist associate or lobbying firm;
- (3) The amount of the expenditure made or incurred by the lobbyist, lobbyist associate or lobbying firm either directly to or on behalf of a covered official or a covered official's immediate family member;
- (4) A description of the goods or services purchased by the lobbyist, lobbyist associate or lobbying firm;
- (5) The date and a description and location of an event paid for by the lobbyist, lobbyist associate or lobbying firm at which covered officials and the covered officials' immediate family members were in attendance; and
- (6) The names of all covered officials and their immediate family members to whom the expenditures were directly made or on whose behalf the expenditures were made or who attended an event paid for by the lobbyist, lobbyist associate or lobbying firm. [PL 2019, c. 587, §14 (NEW); PL 2019, c. 587, §18 (AFF).]

C. A report under this subsection is due no later than 11:59 p.m. on the 15th calendar day of the month following the month in which the expenditure was made or incurred. [PL 2019, c. 587, §14 (NEW); PL 2019, c. 587, §18 (AFF).]

## §319. Penalty

**1. Failure to file registration or report.** Any person who fails to file a registration or report as required by this chapter may be assessed a fine of \$100 for every month the person fails to register or is delinquent in filing a report pursuant to section 317. If a registration or report is filed late, the commission shall send a notice of the finding of violation and preliminary penalty. The notice must provide the lobbyist with an opportunity to request a waiver of the preliminary penalty. If a lobbyist files a report required pursuant to section 317 within 24 hours after the deadline, the amount of the preliminary penalty is \$50. The commission may waive the fine or penalty in whole or in part if the commission determines the failure to register or report was due to mitigating circumstances or the fine or penalty is disproportionate to the level of experience of the lobbyist or the harm suffered by the public from the late registration or report. For purposes of this subsection, "mitigating circumstances" means:

A. A valid emergency determined by the commission, in the interest of the sound administration of justice, to warrant the waiver of the fine or penalty in whole or in part; [PL 2011, c. 179, §7 (NEW).]

B. An error by the commission; or [PL 2011, c. 179, §7 (NEW).]

C. Exemption.** Notwithstanding section 317, subsection 1, a registered lobbyist is exempt from the penalty imposed under this section if, while the Legislature is convened in special session, the lobbyist failed to file a report with the commission pursuant to section 317 if no lobbying has been performed during that special session.
