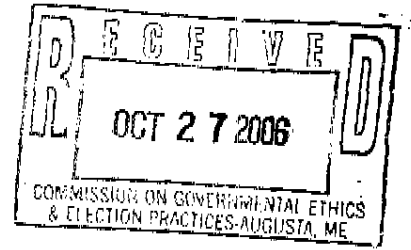



This report is a correction under HD 65, Susan Wasserott. The expenditure of \$3,468.27 to mail 7,540 letters was inadvertently sent to all un-enrolled voters in the towns of West Bath, Woolwich and Topsham. In addition we mailed to 94 un-enrolled voters in Brunswick. District 65 encompasses only a portion of the towns of West Bath, Bath, Topsham and Brunswick containing only 1,567 un-enrolled voters in those municipalities not 7,540.
