The Board of Osteopathic Licensure (hereafter "the Board"), Charles Perakis, D.O. ("Dr. Perakis") and the Office of the Attorney General agree to amend the Consent Agreement executed by the parties on June 10, 2010 as follows:

CONDITIONS

3. Treating Physician.

D. Dr. Perakis shall meet with his treating physician on a bi-annual basis in January and June of each year that the consent agreement remains in effect. The treating physician will provide bi-annual reports regarding the status of Dr. Perakis' treatment, due on the 1st day of February and July of each year that the consent agreement remains in effect.

5. <u>Professional Management.</u>

A. <u>Substance Abuse Counseling</u>. Dr. Perakis shall engage in treatment sessions (individually or group) with a specialist in treating substance abusers who is approved by the Board. The frequency shall be at the discretion of the specialist but no less than **once every other month**. Dr.

Perakis' progress in therapy and compliance with his schedule of meetings on the 1st of each month following the month of each treatment session. The specialist shall immediately report to the Board any failures to appear for scheduled therapy sessions without good cause.

I, CHARLES PERAKIS, D.O., HAVE READ AND UNDERSTAND THE FOREGOING FIRST AMENDMENT TO CONSENT AGREEMENT. I UNDERSTAND THAT BY SIGNING I WAIVE CERTAIN RIGHTS INCLUDING THE RIGHT TO FURTHER HEARINGS OR APPEALS REGARDING THIS FIRST AMENDMENT. KNOWING THIS, I SIGN THE FIRST AMENDMENT VOLUNTARILY, WITHOUT ANY THREAT OR PROMISE. I UNDERSTAND THAT THE CONSENT AGREEMENT DATED FEBRUARY 9, 2012 AND THE CONSENT AGREEMENT DATED JUNE 10, 2010, TOGETHER WITH THIS AMENDMENT CONTAIN THE ENTIRE AGREEMENT AND THERE IS NO OTHER AGREEMENT OF ANY KIND, VERBAL, WRITTEN, OR OTHERWISE. I ACKNOWLEDGE THAT I HAVE HAD THE OPPORTUNITY TO DISCUSS THE CONSENT AGREEMENT WITH LEGAL COUNSEL PRIOR TO SIGNING IT.
