  )      **CONSENT AGREEMENT  
  AND BOARD ORDER**

The Board of Osteopathic Licensure (hereafter "the Board"), Stanley Painter, D.O. ("Dr. Painter") and the Office of the Attorney General enter into the following Consent Agreement in order to resolve a pending disciplinary matter.

**I. FACTS AND CONCLUSIONS**

Dr. Painter admits to the following findings set forth in this Consent Agreement:

1. Dr. Painter has been licensed by the Board to practice osteopath medicine since 1967.

His specialty is general practice.

2. Dr. Painter is the subject of a consent agreement from March 2003, which was amended in December 2005, and restricts his ability to prescribe Schedule II and III medications to patients.

3. In October 2011, the Board received information indicating that Dr. Painter was in violation of his consent agreement, and additional information indicating that Dr. Painter violated 32 M.R.S. § 2591-A(2)(E)(1) and (2) and § 2591-A(2)(F) of the Board's statutes.

4. Absent Dr. Painter's acceptance of this consent agreement by dating and signing it and returning it to Susan E. Strout, Executive Secretary, Maine Board of Osteopathic Licensure, 142 State House Station, Augusta, Maine 04333-0142 by February 25, 2012, this matter will be set for an adjudicatory hearing.

II. SANCTIONS

Based on the foregoing findings and conclusions, Dr. Painter agrees to the voluntary surrender of his license to practice osteopathic medicine.

I, STANLEY PAINTER, D.O., HAVE READ AND UNDERSTAND THE FOREGOING CONSENT AGREEMENT. I UNDERSTAND THAT BY SIGNING I WAIVE CERTAIN RIGHTS INCLUDING THE RIGHT TO FURTHER HEARINGS OR APPEALS REGARDING MY APPLICATION FOR RENEWAL AND THIS CONSENT AGREEMENT. KNOWING THIS, I SIGN THIS AGREEMENT VOLUNTARILY, WITHOUT ANY THREAT OR PROMISE. I UNDERSTAND THAT THE CONSENT AGREEMENT CONTAINS THE ENTIRE AGREEMENT AND THERE IS NO OTHER AGREEMENT OF ANY KIND, VERBAL, WRITTEN, OR OTHERWISE. I ACKNOWLEDGE THAT I HAVE HAD THE OPPORTUNITY TO DISCUSS THE CONSENT AGREEMENT WITH LEGAL COUNSEL. PRIOR TO SIGNING IT.




