The Board of Osteopathic Licensure (hereafter "the Board"), David P. Jones, D.O. and the Office of the Attorney General enter into this First Amendment to the Consent Agreement signed in August 2006 to remove the requirement of a supervising physician.

CONDITION III.1., is replaced by the following:

1. Supervising physician.

A. The requirement that Dr. Jones' practice be monitored by a Supervising Physician approved by the Board or Case Reporter is suspended upon the execution of this First Amendment by all parties. The Board reserves the right to reinstate this requirement, as set forth in the Consent Agreement signed in August 2006, if, in the Board's sole discretion, this appears to be necessary to carry out the original intent of the Consent Agreement.

B. Confidentiality. To the extent allowed by law, the reports that have been submitted by the supervising physician pursuant to this Condition shall not be disclosed to the public.

All other terms and conditions of the Consent Agreement entered into by the parties in August 2006 remain in full force and effect.

I, DAVID P. JONES, D.O., HAVE READ AND UNDERSTAND THE FOREGOING FIRST AMENDMENT TO CONSENT AGREEMENT. I UNDERSTAND THAT BY SIGNING I WAIVE CERTAIN RIGHTS INCLUDING THE RIGHT TO FURTHER HEARINGS OR APPEALS REGARDING THIS AMENDMENT. KNOWING THIS, I SIGN THIS FIRST AMENDMENT TO CONSENT AGREEMENT VOLUNTARILY, WITHOUT ANY THREAT OR PROMISE. I UNDERSTAND THAT THE CONSENT AGREEMENT, AS AMENDED,

CONTAINS THE ENTIRE AGREEMENT AND THERE IS NO OTHER AGREEMENT OF ANY KIND, VERBAL, WRITTEN, OR OTHERWISE. I ACKNOWLEDGE THAT I HAVE HAD THE OPPORTUNITY TO DISCUSS THE FIRST AMENDMENT TO CONSENT AGREEMENT WITH LEGAL COUNSEL PRIOR TO SIGNING IT.


