(As of January 31st, 1935)

In accordance with Section 11 of Chapter 189, Public Laws of 1935, there is presented herewith a roster showing the names and places of business of all registered engineers as of January 31st, 1936. The serial number of each registrant has also been added to this roster.

The law became effective on July 6, 1935. Appointments to the Board were confirmed by the Governor's Council in October, 1935, the certifications of appointment bearing the date of October 31, 1935. The Board held its first meeting and organized on November 13, 1935.

Copies of the law, announcements and application forms were mailed out to engineers all over the State early in December. To date, two hundred and twenty-one engineers have applied for registration. This is an unusually large number of applicants to have filed with the Board in such a short period of time and indicates that the number of pro-

fessional engineers in Maine who will eventually become registered under the Act will doubtlessly be greater than was expected by the sponsors of the law.

The Board realizes that the list of registered men whose names are published herein is not representative of all the engineers in Maine who will register under the law and consequently, by its direction, there is being published this year the names of engineers whose applications have not yet been acted upon by the Board, as well as those whose certificates have been granted.
