
INSURANCE REQUIREMENTS

- Insurance MUST be shown prior to a registration being processed.
 - Verify Coverage Dates
 - Verify Year, Make, Model, Vin #
 - Insurance card may be in a name other than the registrants, provided there is no transfer of ownership.
 - If required to file an SR-22 (Proof of Financial Responsibility) call: (207) 624-9000 ext.52109 for authorization to complete.
 - Call a Municipal Coordinator if unsure.

Additionally:

Customer displays an SR-22 Authorization Letter from the BMV Branch Office. The form must identify the specific vehicle being registered and must be collected once processed. Customer has 30 days to process once issued.

*Proof of insurance can be shown electronically



REGISTRATION PROCESSING DEFINITIONS


- <u>Re-registration</u>: A registration of the same vehicle in the same name in this state.
- Re-registration Transfer: A registration using valid excise tax credit and registration credit from a vehicle no longer in use toward the reregistration of a vehicle on which the registration has expired.
- New Registration/Old Plates: A vehicle being registered in this state by the registrant for the first time using a set of plates previously registered to the registrant. Use of the old plates should be verified by a prior registration or by calling the BMV Main Office. If the prior registration is still valid, it should be turned in so that the customer will not have two registrations showing the same plate number.
- New Registration Transfer: A new registration that uses plates, excise tax credit and registration credit from a vehicle no longer in use by the registrant toward the registration of a new vehicle by that same registrant. Please make sure that the expiration date of the replaced (old) vehicle is still valid prior to giving excise tax credit. 10

REGISTRATION PROCESSING Commercial and Farm Numerical Style Codes

- A truck registered with commercial plates would use one of the following numerical style codes which is indicated in the "STYLE" box on the registration, and MUST include tires, axles and registered weight.
- All commercial style codes are determined by the type of vehicle, the tires, and the axles.


REGISTRATION FORM ERRORS

- If errors are made while typing a registration, please re-type a new registration. <u>Do Not Make Corrections On Original</u>. <u>Do Not Hand Write!</u>
- Errors which may cause a problem include:
 - Incorrect expiration date,
 - Vehicle codes (make, model, style, etc.) missing or incorrect,
 - Typographical errors within the registration,
 - Validation missing or unreadable,
 - Mileage, which is required on all vehicles,
 - Questions 1 and 2 on back of registration unanswered or marked "yes" and processed by the municipality, (if either question is answered "yes" the registration must be processed at a BMV Branch Office,
 - Incorrect or missing date of birth or Federal ID Number,
 - Signatures of parent or legal guardian missing on registration of a minor,
 - Information written near bar coded area.

NEW REGISTRATION: OLD PLATES/TRANSFERS Maine Dealer Sale Only


- NEW REGISTRATION/OLD PLATE (NROP): A <u>new</u> registration using a set of plates previously issued to the registrant. A specialty plate gets treated as a new registration and charged an additional \$20 fee.
- NEW REGISTRATION TRANSFER: A <u>new</u> registration using valid excise tax and registration credit from a vehicle no longer in use.

If purchased private sale or from an out of state dealer, collect <u>EXCISE ONLY</u> and refer the customer to a BMV Motor Vehicle Branch office for processing. <u>DO NOT COLLECT SALES TAX AND/OR TITLE FEES.</u>

• If the customer insists on keeping the old yellow registration mark <u>VOID</u> across it.

NEW REGISTRATION PROCESSING SUMMARY

- Determine the type of transaction the registration will be: NROP (New Registration/Old Plate), New Registration Transfer, or NRNP (New Registration New Plate) which would need processing at a branch or higher-level town.
- Verify insurance and that no SR-22 insurance is required.
- Record the previous title number and CTA number on the front side of the white registration form along with the correct month and year sticker control numbers.
- The customer <u>must</u> complete the reverse side of the registration (white copy) with the mileage, questions, and signature line.
- Collect all fees and validate the registration form (white and yellow copies) and give the customer the yellow copy. Retain the pink copy for your municipal records and send the white copy to the BMV Main Office with your cash report.

RE-REGISTRATION/TRANSFER

- Valid excise tax and registration credit from a vehicle no longer in use may be used toward the re-registration of another vehicle on which the registration has expired.
- Registration expired March 31, 2022.



- Automobiles, trucks, truck tractors, motorcycles, mopeds, motor driven cycles, camper trailers and buses shall be charged one half the excise tax and one half the registration fee if registered during the last four (4) months of the registration year.
- Vehicles that have mandatory February expiration dates, the registration fee would be half rated as of November 1st.
- In the event of a late re-registration of a truck tractor, the \$40.00 credit allowed will be half rated, as well as the excise tax and registration fees.
- Excise tax and registration fees for a <u>farm truck</u> are half rated during the last six (6) months of the registration year.

- Which fees get half-rated on a registration?
- Can someone other than the registrant come in for a duplicate registration?
- What options are available rather than doing an early renewal?
- Can I change the expiration date if the registrant comes in 7 months late to register their vehicle?
- If my registration expires in October, in what month will the registration be half-rated?
- If processing excise only, when is the only time you would put an expiration date on the registration?

NAME CHANGES

- <u>Court Ordered</u>: A name may be changed on a current registration at any time due to a divorce, marriage or court order. Review the proof of the name change document and submit a copy. If their license has been changed to reflect the new name, document copies will not be required.
- <u>Change From Individual to Corporate Name</u>: This change can be allowed anytime during the registration year, but only when the individual is the sole owner of the corporation.
- <u>Change from Corporate Name to Individual Name</u>: This change cannot be processed as a correction. It must be processed as a new registration with full payment of ALL fees.
- When a Corporation is Changing their Name due to New Ownership: The transaction is considered a New registration. This requires new plates to be issued, a new title application and sales tax form, with all fees collected. A private individual cannot register a vehicle as DBA if their company is incorporated or an LLC.

LEASED VEHICLES

LESSOR: The owner of a vehicle that is leased under an agreement to a Lessee. LESSEE: Makes a one-time payment or periodic payments to the Lessor in return for the use of a vehicle.

- The customer needs to provide a copy of the lease agreement. It is the owner of the vehicle (lessor) who decides who is listed on the registration. The registration must match the lease agreement exactly.
- When transferring plates, a Name Addition/Deletion form (MV-138) may be required if the prior registration does not match the new lease agreement. If a name needs to be added to a leased vehicle registration, the customer needs to get an amended lease indicating the change.
- When a customer buys out a lease it is processed either as a <u>New Registration</u> or a <u>New Registration Transfer</u>.
- If purchased directly from the Lessor, process <u>excise only</u> and send customer to a Branch Office to account for Title and Sales Tax fees.

- NAME ADDITION/DELETION: A name may be added or deleted on a current registration at anytime during the registration year.
- The Name Addition/Deletion Form (MV-138) is used.
- A signed, notarized statement is also acceptable.
- NAME ADDITION requires signatures by all parties involved.
- NAME DELETION requires only the signature of name being deleted.
- NAME ADDITION/DELETION on a low digit plate requires written permission from Secretary of State's office
- The sole titled owner of a vehicle cannot be deleted from a registration unless it is a <u>court ordered</u> suspension.


NAME ADDITIONS/DELETIONS

 Determine if the intent is to change ownership prior to processing the name addition/deletion request. If the intent is to change ownership, the transaction should be processed as a new registration and the title must be signed over to the new owner. Collect excise tax before sending the customer to the BMV Branch Office for processing.

 <u>Only</u> when the Name Addition/Deletion Form leaves your office does it need to be notarized when brought back in to either the BMV Branch or Municipal Office.


NAME ADDITION/DELETIONS

- It may be necessary to use the MV-138 when doing a NROP or Transfer
- The names on each side have to "balance" like on a see-saw.



NAME ADDITIONS/DELETIONS

 It may be necessary to use the MV-138 when doing a NROP or Transfer when there is one name on MVT-2 and customer wants two names on registration.



SURVIVING SPOUSE, HEIR OF THE DECEASED, OR PERSONAL REPRESENTATIVE

- A surviving spouse is the surviving wife or husband only. It does not include any other relative.
- Verify registrant's death and the current registration certificate. If the registration is current, process a <u>correction</u> to remove the deceased and/or to add the surviving spouse.
- Disability Plates that were issued upon application to the deceased must be surrendered and replacement plates issued at no fee. This can only be done at a BMV Branch Office.
- When processing a re-registration, it is not mandatory that a new title application be completed at the time of renewal. Simply indicate "Surviving Spouse" on the registration and change/remove the name of the deceased. If an additional person is being added to the registration an MV-138 form will need to filed with the registration.

LIVING TRUST

- A Living Trust is a fund that is established to include an individual's assets.
- When an individual who has a current registration on a motor vehicle decides to put the vehicle into a living trust, that individual is no longer the owner of the vehicle.
- The customer <u>must</u> furnish a copy of the trust papers.
- This type of transaction must be processed as a new registration even if the person named in the trust was the previous owner of the vehicle. Verify the information on the trust and DO EXCISE ONLY!
- A "Revocable" (Temporary Living Trust) Federal ID # is not required but must indicate Trustee(s) date(s) of birth.
- An "Irrevocable" (Permanent Living Trust) Federal ID # is required.

AFFIDAVIT FOR REISSUANCE OF SUSPENDED REGISTRATION

 If a registration has a court ordered suspension, the Secretary of State may reissue that registration to a spouse, domestic partner, or family member. Completion of the Affidavit for Authorization for Issuance of Suspended Registration form (MV-83) would be necessary when the person under suspension is the sole titled owner. The Name Addition/Deletion form (MV-138) will always be necessary when adding or deleting a name from a registration.

REVIEW QUESTIONS

- A customer comes in and states she has a new last name and would like to change it on her registration. What is considered acceptable proof?
- A customer requests to have her named added to her boyfriend's registration. She states he works during office hours and can't come in to sign anything. How do you proceed?
- A husband and wife come in to remove his name from a registration because he has to file an SR-22 and now his right to register is under suspension. How do you proceed?
- A husband and wife come in to have her name added to a leased vehicle registration. How do you proceed?
- A customer just purchased a new vehicle and wants to do a new registration/transfer. The previous registration was in his and his father's name. The new registration is to be in his name only. You inform him that Dad needs to sign the MV-138. He then states "go ahead and keep it in both names". How do you proceed?

REGISTRATION OF INCORRECT VEHICLE

- If the wrong vehicle is registered there could be serious problems if the registrant is stopped by law enforcement. Use the following steps to correct the registration to reflect what was done incorrectly:
 - 1. Collect the incorrect yellow registration and stickers, if possible, from the customer.
 - 2. Pull the correct preprint or type a new form. (Manual towns)
 - 3. Indicate in the note field "CORRECTION REGISTERED INCORRECT VEHICLE".
 - 4. Collect any additional fees.
 - 5. <u>Do Not</u> charge a registration fee if they have already paid the correct amount. If an additional amount is collected, show this amount as "balance due" on your Cash Report.
 - 6. Validate all registration copies.
 - 7. Send incorrect yellow and corresponding stickers along with the new white copy to the BMV Main Office.
 - 8. Give the yellow corrected copy and stickers to the customer.
 - 9. Retain the new pink copy for your records.
 - 10. <u>Do Not</u> count this registration under "UNITS" in your Cash Report. This is only a correction.

VEHICLE IDENTIFICATION NUMBER ERRORS

- VIN corrections may be done by a Municipal Agent at any time during the registration year.
- The VIN can be verified by having law enforcement or an inspection station complete the MVT-10 form (Inspection of Vehicle Identification Number).
- Verification may also be done by selected employees and agents of the Bureau of Motor Vehicles.

PROCESSING INSTRUCTIONS:

- 1. Verify the VIN on the vehicle.
- 2. Manual towns should indicate "Corrected VIN" in space provided.
- 3. Retain the old yellow registration (if available).



- Registrants <u>must</u> be encouraged to return plates that are not in use so that their responsibility for these plates will end.
- Complete the Returned Plate card (MV-553) and send in with your Cash Report upon receiving returned plates.
- Any plates returned should be placed in a recycle bin to be returned to the BMV Main Office.
- Call a Municipal Coordinator if registrant information is unknown.

- There is a charge for lost stickers:

- Orders must be emailed or faxed to theStockroom at: (207) 624-9035.
- When ordering by phone, give the BMV Stockroom the name of the municipality and a list of the items needed. Provide the form number, which is usually found in the bottom left-hand corner of the form. For example: MV-138, MVR-60, MVT-2, etc. This helps speed up the order, as it gives the Stockroom staff an exact description of the items needed.
- Most orders are currently shipped UPS ground and can take 1-5 days for delivery.
- The yellow or blue Use Tax Certificates are ordered directly from Maine Revenue Services at (207)624-9693.

- A municipality may pick up their supplies directly from the BMV Stockroom. The BMV Stockroom requires proof of municipal employment before issuing supplies to walk-in customers. Provide stockroom staff with a copy of the MV-51 that has been validated with the municipal validation stamp or a statement on municipal letterhead. If this identification is not provided, supplies will not be issued.
- Verify sticker quantities each week and order appropriately so as not to run out, which will disservice the customer.
- Notify Municipal & Agent Services at (207) 624-9000 ext. 52163 immediately of any address changes or changes in the Tax Collector and/or Municipal Agent.

NOTE:

- It is never acceptable for municipalities to swap and/or loan stickers, plates or any numbered forms with any other municipality. This is tracked inventory and must remain consistent with your reports.
- It is never acceptable to misuse stickers issued by cutting double stickers to issue as single stickers, or by using two single stickers as a double.



Make sure to include the individual's current address.

FEES PAYABLE TO THE BMV

- There are different ways that a municipality may pay the Bureau of Motor Vehicles for the registrations that are processed by the municipality:
 - 1. Contact your local bank to establish deposits into the State account. Deposit slips must read as follows: Bureau of Motor Vehicle Town of _____
 - 2. Municipal check made payable to <u>Secretary of State</u>.
 - 3. Money orders are accepted, but all checks must be made payable to the municipality first before obtaining a money order.
- State funds <u>MUST NOT</u>, under any circumstances, be intermingled with personal funds. Once the customer leaves the office, municipalities <u>MAY NOT</u> refund or rebate the state fees.







- The Cash Office has requested that the materials not be folded or rolled when submitting. PLEASE MAIL FLAT.
- Remember to use the town's validation stamp on the outer envelope near the return address and enter the date range of the report on the validation stamp.
- Cash reports need to be sent to: Secretary of State, Bureau of Motor Vehicles, Accounting Unit, 29 State House Station, Augusta, Maine 04333.
- PREPRINT DATA: In place of paper preprints, a delta file with updated registration information will be made available to electronic municipalities on the InforME website on a monthly basis. In order to ensure that municipal registration records are kept as up-to-date as possible (including any suspension information), this data <u>must be loaded into the electronic</u> <u>system</u>. Data not retrieved in a timely manner will be reported to the Bureau of Motor Vehicles, Audit Services by InforME.

CASH REPORTING

- Insurance: With the exception of the TL and SE class codes, all registrations should be initialed for proof of insurance at time of renewal.
- Verify that all registrations for the reporting period listed are included within the report.
- Town Summary must be <u>signed</u> by the authorizing agent or staff member completing the report.
- Inventory: Manual counts of the inventory (stickers and forms) <u>MUST</u> still be performed in connection with each cash report. The verification process should include not only amounts, but also the ranges listed within the inventory as available.

Bundle the following information top to bottom:

- 1. Requests for Duplicates (MV-11), Replacement Stickers (MV-14), Lost Plate forms (MV-9).

- 4. Corrections.
- 5. Any Registrations with attachments (example: Power of Attorney, emancipated minor).
- 6. Transfers.
- 7. All other registrations bundled by class code.

- 1. The registrant states that he or she relies primarily on public transportation as their primary mode of transportation.
- 2. The registrant states that he or she lives in a household where there is a primary vehicle registered to another person in that household. Obtain that plate number and compare the addresses.
- 3. The registrant is a seasonal resident and the primary vehicle is registered out-of-state. Obtain the out-of-state plate number.

Motor Vehicles hauling camper trailers are exempt from gross vehicle weight restrictions with the exception of 5th wheel campers. The registered weight of the hauling vehicle must include the 5th wheel camper.

LAW ENFORCEMENT & LEGISLATIVE PLATES



- County Sheriff Plates are registered through BMV Main Office.
- State Police Plates are issued and maintained by their own department.
- Legislative Plates are issued and renewed from BMV Main Office.
 - A Legislator must register regular number plates in the normal manner, but will carry two valid registrations to display legislative plates.

- All Municipal Plates are issued through BMV Branch Offices or BMV Main Office.
- Municipal Police renewals and transfers may be processed at local municipalities.
- Registration, Excise Tax, Sales Tax, and Title paperwork are processed, but fees are exempt.
- Vehicle owned or leased by municipalities are issued municipal plates.
- No Title required on vehicles loaned to secondary schools for driver's education use.
- No stickers are issued.

NATIONAL GUARD





- Class Code is PC, but the plate always ends with NG.
- NG is not a vanity plate.
- Vanity plate not available.
- Applicant must contact the Adjutant General's Office at Camp Keyes, (207) 626-4205 to request these plates.
- When two names appear on registration DO NOT DELETE either name without calling BMV.

PASSENGER



- Designed for the conveyance of passengers with a seating capacity of not more than 15 persons, including the operator of the vehicle.
- Maximum allowed weight is 10,000 lbs. r.v.w.
- Insurance required for registration.


DUNE BUGGY & STOCK CARS



- Passenger Plate is used for Dune Buggy and Stock Cars for public way use only. Dune Buggy must pass full inspection to be registered for On-Road use.
- Registration Fee is \$25 for Dune Buggies.
- Registration Fee is \$8 for Stock Cars.
- Excise Tax and Sales Tax must be paid.
- Dune Buggy is registered as a Stock Car for Off-Road Use.
- Off-Road Use: Indicate "Not to be operated on highway under own power".

AGRICULTURE PASSENGER, COMMERCIAL, and FARM

(Specialty Plate)






- \$20 First time fee and \$15 for renewals.
- AG maximum allowed weight is 10,000 lbs. r.v.w.
- AF maximum allowed weight is 69,000 lbs. r.v.w.
- AC maximum allowed weight is 100,000 lbs. r.v.w.
- MV-60 Truck Fee Schedule is used for Commercial and Farm calculations.
- First time issue of the Agriculture Commercial and Agriculture Farm is at BMV Branch Office.
- \$10 of the specialty plate fee will be credited to the Maine Agriculture in the Classroom Council.



CONSERVATION PASSENGER, COMMERCIAL, DISABLED, MOTOR HOME, and TRAILER

(Specialty Plate)



- \$20 First time fee and \$15 for renewals.
- CR and CD maximum allowed weight is 10,000 lbs. r.v.w.
- RV maximum allowed weight is 69,000 lbs. r.v.w.
- CC maximum allowed weight is 100,000 lbs. r.v.w.
- MV-60 Truck Fee Schedule is used for Commercial, Farm and Motor Home calculations. Trailers are calculated based upon the trailer r.v.w. chart.
- First time issuance at a BMV Branch Office for the Conservation Disability (CD).
- A \$14 Tax Deduction is allowed on your Income Tax Return.

Animal Welfare, Maine Black Bear, Breast Cancer, Barbara Bush, Lobster, Lobster Commercial, Maine Lighthouse Trust, Support Wildlife, Support Troops and University of Maine

(Specialty Plates)



- \$20 First time fee and \$15 for renewals, with the exception of the Support Wildlife Plate which is \$20 first time and at renewal time.
- Produced with a unique 3 number and 3 letter combination sequence.
- Vanity Plates available for \$25 first time ~ six character maximum and cannot duplicate vanity plates issued in another class of plates.
- Review the BMV Procedures Manual for money designation from these plates.
- University of Maine plates are available to any Maine resident and funds go to support the Maine System Scholarship Fund.

- Must be Federally recognized by a tribal official.
- Maximum allowed weight is 10,000 lbs. r.v.w.
- Produced with a unique 3 number 3 letter combination sequence.
- MV-18 is a two-part form and must be completed and signed by tribal official. The white copy is for the registrant and yellow copy is retained by the tribal official.
- In lieu of the MV-18 to prove eligibility, an official Tribal Membership Card may be used. The card will contain a photo of the tribal member, their name, signature and a tribal official's signature.

Note: The Wabanaki Veteran Decal <u>CANNOT</u> be attached to this plate.

OFF ROAD VEHICLE









- Off-Road vehicles cannot be registered.
- Off-Road Use may be indicated on the Manufacturer's Certificate of Origin.
- Off-Road vehicles, not a moped or motorcycle, do not meet inspection standards as listed in Title 29A, Section 101, Subsection 47-A.
- Examples of Off-Road Vehicles, but not limited to: Pocket Bikes, Mules, Gators, and Mini-Trucks.
- Utility-terrain vehicles or UTV is a small vehicle like an ATV, but with truck-like features for working rather than recreational use. These UTV vehicles cannot be registered for public road use.

Road Tractor:

- Designed and used primarily for drawing other vehicles, but not constructed to carry any load.
- Registration fee is \$20 for Road Tractors.
- Staggered registration 1 year from the month of issue.
- No Vanity Plate allowed.

Farm Tractors and Homemade Tractors:

- Used primarily as a farm implement for drawing plows and mowing machines.
- Registration fee is \$5 for Farm Tractors and Homemade Tractors.
- Indicate <u>Farm Use Only</u> on the top of the registration.
- Travel allowed within a 10 mile radius of the farm.
- Staggered registration 1 year from the month of issue.
- No Vanity Plate allowed.

SPECIAL EQUIPMENT



- Equipment drawn by a motor vehicle. Example: wood splitters, pumps etc.
- Excise Tax Exempt.
- Registration based upon Net Weight:
 - 1 to 2,000 lbs. \$10 2,001 to 5,000 lbs. \$15 5,001 lbs. + \$20
 - Mandatory February Expiration.
 - Indicate "Exempt" on excise tax balance line.
 - Net weight, tires and axles must be indicated on registration.
 - No Vanity Plate allowed.





TRAILERS ~ SMALL and LARGE







- Registration Fee \$10.50 annually for trailers (small) 2,000 lbs. or less and \$20.00 annually for trailers (large) over 2,000 lbs. r.v.w.
- 2-year registrations allowed on non-excised trailers, collecting twice the Registration Fee and Vanity (if applicable) Plate Fee. Type "Non-Excise" on tax line and "Exempt" on the Excise Tax line.
- 2,000 lbs. r.v.w. or less has staggered month expiration.
- Over 2,000 lbs. r.v.w. has mandatory February expiration for non-excised trailers.
- Trailers must be Titled when weight is 3,000 or more and 1995 or newer.
- Collect excise tax when trailer has living quarters.
 Camper trailers are only allowed a 1-year registration.

- Sales Tax is due on ALL casual sales of ALL trailers, campers, and livestock trailers.

- REMEMBER: All trailers OVER 3,000 lbs. (net/ unladen weight) and 1995 or newer MUST be Titled.

TOW DOLLY

- Maine <u>does not</u> require registration.
- A registration may be requested when traveling through other states that may require a registration for a Tow Dolly.
- <u>Cannot</u> be registered for over 2,000 pounds.
- The vehicle in tow <u>must</u> be registered or display a transit plate.
- Registration fee: \$10.50 for 1 year, \$21 for 2 years.
- Staggered registration

TRUE TRAILER

- <u>Must</u> have a front and rear axle.
- Registration Fee based upon (top portion) MV-60 Truck Fee Schedule.
- Mandatory February expiration.
- May register for two (2) years.
- Single Plate.

- Transit Permit Application (MV-159) and a fee of \$12 along with a Certificate of Taxes Paid (MV-47), even if taxes have not been committed.
- Municipalities may collect a \$1.00 service fee over and above the transit plate fee.
- Travel on a Transit Plate must be completed within 10 days.
- Over-limit Permit needed from BMV for homes over 45 feet long or combination hauler and home over 65 feet long.

TRANSIT PLATE



- Transit Permit Application (<u>MV-159</u>). Fee is \$12 for one-way and \$25 for round trip.
- The round-trip permit allows the movement of a vehicle from point A to point B, and then returning to point A.
- Validation needs to be on both copies of the application.
- Municipalities may collect a \$1.00 service fee over and above the transit plate fee.
- Travel on a Transit Plate <u>must</u> be completed within 10 days.

VETERAN PLATES

How Do I Know What Plate To Issue a Veteran?

There are multiple Special Veteran and Disabled Veteran categories:

- 1. Special Veteran (VT and VM-motorcycle)
- 2. 100% Disabled Veteran (DV-flag, VX-parking and XV-motorcycle)
- 3. Amputee or Blind Veteran (choice of plate)
- 4. Disability Special Veteran (DS)
- 5. Purple Heart (PH and PM-motorcycle)
- 6. Prisoner of War (PO)
- 7. Pearl Harbor Survivor (PS)
- 8. Medal of Honor (MO)
- 9. Gold Star Recognition (GS)
- The Veteran is required to submit their DD214 indicating Honorable Discharge from the military.
- The Veteran's Administration provides a letter explaining a Veteran <u>MAY</u> be eligible for exemptions.
- The Veteran's Administration letter is <u>NOT</u> an automatic eligibility for exemptions.

- DD214-issued after discharge
- Active Duty for 3 Years
- Veteran Status on Maine License

- Requires VA Paperwork stating 100% Disabled or being paid at 100%
- Loss of Lower Extremities, or Legally Blind

Purple Heart (PH)

Purple Heart MC (PM)

- New Reg: Excise Only!
- Complete at Branch
- Pays Excise Tax
- Registration & Title Fees Exempt
- DD214 indicating eligibility



Disability Special Veteran Parking (DS)

- New Reg: Excise Only! Complete at Branch
- PS-18 Application for Plaque Card



- <u>Must</u> pay Registration, Title fee, Excise Tax and Sales Tax.
- Maximum registered weight is 26,000 lbs. r.v.w.
- Allowed up to 3 sets of plates.
- May be issued in a company name if the company is solely owned by the Veteran.
- Surviving Spouse may retain and display Special Veterans plates. Upon remarriage, the surviving spouse may not use these plates but may retain as a keepsake.





- Operator must possess a valid Maine license, permit, or motorcycle endorsement.
- Automatic March expiration.
- Titled if 300cc or greater.

DISABLED VETERANS

100 % Permanently Disabled Veteran ~ Service Connected

<u>Must</u> use Placard to park in handicapped parking.



Disabled Veteran Parking



Disabled Veteran Motorcycle

- If the veteran is less than 100% permanently disabled (90%, 80% or less) but is being compensated at 100% total with permanent benefits, the veteran qualifies for BMV benefits at 100% capacity.
- Excise, Registration and Title Fee Exempt, but Vanity Plate is \$25.
- The veteran's name must appear on the registration and title.
- Must pay Sales Tax.

DISABLED VETERANS

Amputee/ Loss of Use of Lower Limb(s) or Blind Veteran



- Exemption allowed on <u>One Vehicle Only</u>.
- Vehicle must be a Government issued vehicle.
- May choose from the following plates: PC, VT, or DV.



- Registration, Excise Tax, Title Fee, and Sales Tax are all exempt.
 - Vanity plate fees apply and are not exempt.



 More than one name may appear on the registration form provided one of them is the veteran's name.

DISABLED VETERANS

SPECIAL VETERAN DISABILITY PARKING:



- Veterans that have a military/non-military disability.
- Form PS-18 must be submitted every 6 years.
- <u>Must</u> pay Registration, Title Fee, Excise Tax, and Sales Tax.

PURPLE HEART and PURPLE HEART MOTORCYCLE:









- Not entitled to free parking privileges for disabled veterans.
 - Registration and Title Fees are Exempt.
 - March expiration for motorcycles.
- Must pay excise and sales tax.
- Vanity Plate available for \$25.
- Maximum registered weight is 10,000 lbs. r.v.w. for vehicle.
- Unmarried surviving spouse may display plates.
- Remarried surviving spouse may retain plates as a keepsake only.
- Recognition plate available when recipient has no vehicle for a one-time fee of \$5.
- Recognition plate cannot be displayed and says "AWARD".

Allowed 2 vehicles (PH) and 1 motorcycle (PM) plate.

PRISONER OF WAR

 Issued through the office of the Secretary of State to former Prisoners of War and their spouse.



- No fee for surviving spouse to have the POW plate, but the appropriate military verification <u>must</u> be submitted.
- Excise Tax, and Sales Tax <u>must</u> be paid.
- Registration and Title Fee Exempt.
- Vanity plate <u>not</u> available in this plate.

PEARL HARBOR SURVIVOR



- Only issued to the Pearl Harbor Survivor who was stationed in Pearl Harbor, Oahu, Hawaii, during the Japanese attack on December 7, 1941.
- First issued at BMV Main Office.
- Excise Tax, and Sales Tax <u>must</u> be paid.
- Registration and Title Fee Exempt.
- Vanity plate <u>not</u> available in this plate.
- The plate number <u>always</u> begins with zero.

GOLD STAR FAMILY RECOGNITION PLATE:




- An application for Gold Star Family Member plates must be accompanied by proof that the applicant has been awarded the gold star medal. The Secretary of State shall verify the documentation presented by the applicant. Misrepresentation of documents is in violation of section 2103, subsection 5.
- The Secretary of State may issue Gold Star Family Member plates for display only on an automobile or pickup truck. A recipient may be issued Gold Star Family Member plates for no more than 2 vehicles.
- Exempt from registration and title fee only.
- Excise tax must be paid.
- Vanity plate fee \$25.

MEDAL OF HONOR:



- Must apply with a copy of the military orders awarding the Medal of Honor.
- Exempt from Registration and Title Fee only.
- Excise Tax <u>must</u> be paid.
- Vanity plate Fee \$25.
- First registration <u>must</u> be processed at BMV Main Office.
- Registration Fee box will indicate No Fee Section 524.



VETERAN COMMEMORATIVE DECALS

- Commemorative Decals can be purchased with proper documentation.
- Purchased through BMV and/or Branches for \$5 per set, with free lifetime replacement.
- Evidence of military award or branch of service (DD214, Honorably Discharged).





WABANAKI VETERAN DECAL

 Once a DD214 and Wabanaki qualifications have been confirmed, this Veteran may purchase the Wabanaki Veteran Decal and place it only on the Special Veteran Plate (VT) or the Disability Special Veteran Plate (DS).

- Members of the armed forces who are active duty and stationed full time at a <u>MAINE BASE</u> are <u>EXEMPT</u> from <u>EXCISE TAX</u>.
- The vehicle must be owned (and titled when applicable) by the military person, for any exemptions to be given. (A registration is not proof of ownership).
- This <u>DOES NOT</u> include National Guard or Reserves.


