What is the role and scope of the commission?

- Non-partisan commission but what level of comfort do we have regarding recommendations on issues that can seem partisan
- To consider what issues are non-partisan but may seem partisan/have been politicized to stay true
- Existence of commission is for the advocacy for women and women's issues
- Think about end goal and work with people to help advocate for change without people shutting down before the conversation can even happen
- Make a framing document what is it important for us to do from a lived inclusivity of women's lens
- Have a retreat?
- How to educate others that the commission exists?

Filling commission seats

- Come up with the ask for filling the seats
 - Empty seats (all Gov appointments):
 - REPRESENT THE ELDERLY (Jill)
 - LOW-INCOME PEOPL REPRESENT PERSONS WITH DISABILIITES
 - REPRESENT AND WORK WITH VICTIMS OF DOMESTIC VIOLENCE (Rebecca)
 - REPRESENT THE FEDERALLY RECOGNIZED TRIBES IN THE STATE
 - All at large seats (filled by Senate and House leaders) are filled.
 - We also need the Gov to officially appoint Rebecca as Chair
 - o Recommendations to the Governor, etc.
 - They will do the background work
 - Sue will talk with the Governor
 - Commission members to contribute names to a Google doc that Kate is creating;
 consider geographic areas as well
 - Learn about the history of the tribal seat from Nicole Rebecca will reach out
 - o Goal to go into 2021 with a full commission

PCSW Website
