Report Committee - Anne

Next report should help the Legislature understand the impact of the pandemic on women in ME. No staff to do the report. MSW and law students could be available to assist. Look at what organizations already have. Work with Catholic Charities re: underserved communities. Offer stipends to those sharing their stories. One-pager for December, prior to Cloture. Focus on a narrow range of issues. Childcare continues to be a huge issue. Showcase how state government can help.
