Pending before the Board is a Petition for Extension of Benefits filed by Isabelle Stewart concerning a March 29, 1993 date of injury.

Ms. Stewart has received 312 weeks of incapacity benefits. She is seeking an extension of her entitlement to incapacity benefits because of extreme financial hardship due to inability to return to gainful employment, pursuant to 39-A M.R.S.A §213(1).

As evidence, the Board considered the testimony of Isabelle Stewart taken on December 7, 1999; Employee Exhibit No. 1 (consisting of Part A: an itemization of Ms.

Stewart's monthly income and expenses; Part B: Ms. Stewart's 1998 TeleFile Tax Record and W-2 Statement; and Part C: copies of bills); Employee Exhibit No. 2 (Ms. Stewart's wage stubs from July 8, 1999 through October 28, 1999); and Employee Exhibit No. 3 (medical reports from Gregory Pomeroy, M.D.).

DECISION AND ORDER

- 1. As a result of a March 29, 1993 injury to her right foot, Ms. Stewart's capacity to work has been restricted to four hours per day and 20 hours per week.
- 2. Effective November 12, 1999, Ms. Stewart's incapacity benefits were discontinued.
- 3. Ms. Stewart, who is 62 years old, has worked for St. Joseph's Manor for over 20 years. Ms. Stewart continues to work for St. Joseph's Manor, subject to her restrictions, when St. Joseph's is able to provide work for her. Before her injury, Ms. Stewart was consistently able to work well in excess of 20 hours each week. She has not been able to return to that level of employment due to her injury.
- 4. Ms. Stewart's monthly expenses exceed her monthly income even though she continues to work as much as she can for St. Joseph's Manor.
- 5. Due to her injury, Ms. Stewart is experiencing extreme financial hardship.

WHEREFORE, on a vote of 6-1, Ms. Stewart's Petition for Extension of Benefits is GRANTED. Ms. Stewart is entitled to partial incapacity benefits at a varying rate from November 12, 1999 to the present and continuing.
